







**Lecture on Careers in International Law and Diplomacy
August 22, 2023**

A guest lecture on Careers in International Law and Diplomacy was organized by the Centre for Alternative Dispute Resolution, Rajiv Gandhi National University of Law, Punjab in collaboration with the RGNUL Legal Aid Clinic. The lecture was delivered by Mr. Vikram Raghavan, who graduated from the National Law School of India University, Bangalore, and proceeded to do his LL.M. at New York University School of Law. Currently, he is a lead counsel at the World Bank in Washington, D.C.

The lecture started with Mr. Raghavan giving a brief introduction of himself and his journey to the World Bank, and then he moved towards the journey and success of his batchmates and other NLU graduates, who are currently holding prestigious jobs in international law arena, including in international courts and tribunals, international law firms, and other international organizations. He then explained how students can prepare for opportunities in international law from the beginning of their law school career. After attending to some of the doubts of the students regarding internships, publications and career opportunities, he proceeded with the second part of the lecture, in which he dealt with the history of the IMF and the World Bank, explained at length about the Bretton Woods Conference, and explained how both institutions work. The lecture came to an end with another question-and-answer session in which Mr. Raghavan tried to answer all the questions. The students found the session highly informative and useful.
