# ABOUT RGNUL

The Rajiv Gandhi National University of Law (RGNUL), Punjab, was established by the State Legislature of Punjab by passing the Rajiv Gandhi National University of Law, Punjab Act, 2006 (Punjab Act No. 12 of 2006). The Act incorporated a University of Law of national stature in Punjab, to fulfill the need for a Centre of Excellence in legal education in the modern era of globalization and liberalization. The University was accredited with 'A' Grade by National Assessment and Accreditation Council (NAAC) in 2015. RGNUL, Punjab was granted autonomy under UGC Regulations, Clause 5 Dimensions of Autonomy for Category-II Universities in April 2018. The Ministry of Human Resource Development, Government of India, ranked RGNUL the first amongst the cleanest Higher Educational Institutions, Swachh Campus (2019) in the category of Government Residential Universities. The major Objective of the RGNUL, Punjab states, "Our endeavour is to serve the society through reforms in legal services by way of preparing professionally competent lawyers, inquisitive researchers, able administrators, conscientious judicial officers, and above all, socially responsible citizens, who shall be wholeheartedly and continuously engaged in the process of nation building."

The University has set up eighteen centres of research. These include, Centre for Advanced Study in Criminal Law (CASCL); Centre for Consumer Centre for Advanced Study in International Humanitarian Law (CASH); Protection Law and Advocacy (CCPLA);

Centre for Advanced Studies in Human Rights (CASIHR); Centre for Advanced Studies in Labour Welfare (CASLW), Centre for Environmental Legal Studies (CELS), Centre for Advanced Studies in Energy Laws (CASEL), Centre for Alternative Dispute Resolution (CADR), Centre for Constitutional Law and Governance (CCLG), Centre for Criminology, Criminal Justice and Victimology (CCV), Centre for Innovation and Intellectual Property Rights (CIIPR) and Centre for Business Laws and Taxation (CBLT). School of Agricultural Law and Economics (SALE); Centre for Advanced Studies in Cyber law and Artificial Intelligence (CASCA); School of Social Sciences and Interdisciplinary Studies (SSSIS); RGNUL Institute for Competitive Examination (RICE) and Directorate of Distance Education (DODE) have also been established. The objective of these Centres is to undertake advanced study and research in the emerging areas of the respective fields, independently or in collaboration with professional institutions at the national or international levels; to bring about publications and produce study material in the respective fields of knowledge; organize seminars, workshops and conferences on contemporary and significant issues. IGNOU School of Law is also functional at RGNUL.

The University has instituted a Legal Aid Clinic under the aegis of Punjab Legal Services Authority. The RGNUL Legal Aid Clinic, established in 2011, has a Strong Paralegal Volunteer Force of 110 members consisting of Advocates, Faculty members and students in general.

## ABOUT

### Ministry of Social Justice and Empowerment

In 1985–86, the Ministry of Welfare was restructured by creating the Department of Women and Child Development and retaining the Department of Welfare. At the same time, divisions for Scheduled Castes, Tribal Development, Minorities, Backward Classes, and Wakf were transferred from other ministries to consolidate welfare efforts. In May 1998, the ministry was renamed the Ministry of Social Justice & Empowerment (MoSJE). Later, the Tribal Affairs division was carved out to form a separate ministry in 1999, followed by the formation of the Ministry of Minority Affairs in 2007, which included the Minorities and Wakf divisions. That same year, the Child Development division was moved to the newly established Ministry of Women & Child Development.

Although disability is a subject under the State List, the Central Government has been proactive in the sector by operating national institutes and regional centers, funding NGOs, and offering concessional loans through the National Handicapped Finance & Development Corporation. India is also a signatory to international agreements like the 1992 Beijing Proclamation and the UN Convention on the Rights of Persons with Disabilities (UNCRPD), which took effect in 2008. However, within MoSJE, disability matters were handled by a single bureau, limiting its effectiveness. Recognizing the need for a focused approach, the 11th Five Year Plan recommended the creation of a dedicated department.

On January 3, 2012, the government approved, in principle, the establishment of a Department of Disability Affairs. This decision was formally announced by the President in Parliament on March 12, 2012. Finally, on May 12, 2012, two departments were created within MoSJE: the Department of Social Justice and Empowerment and the Department of Disability Affairs, which was later renamed the Department of Empowerment of Persons with Disabilities (Divyangjan).

## ABOUT

### The National Institute of Social Defence (NISD)

The National Institute of Social Defence (NISD), located in New Delhi, is the nodal training and research institute under the Ministry of Social Justice and Empowerment, Government of India, focusing on social defence. It was initially established as the Central Bureau of Correctional Services in 1961 and later became an autonomous body in 2002. NISD plays a key role in developing policies, programs, and tools for social defence, particularly in areas like drug abuse prevention, welfare of senior citizens, and transgender and beggary prevention.

The National Institute of Social Defence was set up originally as the Central Bureau of Correctional Services in 1961, under the Ministry of Home Affairs, in pursuance of the recommendations emerging at various National Forums. In 1964, the Bureau was transferred to the then Department of Social Security.

Since 1975, the Institute was a subordinate office under the Ministry of Social Justice and Empowerment. The National Institute of Social Defence has become an Autonomous Body vide Government of India Notification No. 10-3/2000-SD. Vol. II, dated July 15, 2002, and is registered under the Societies Act XXI of 1860 with the Government of NCT, Delhi.

The National Institute of Social Defence is the nodal training and research institute in the field of social defence. Though social defence covers the entire gamut of activities and programmes for the protection of society, it is currently focusing on human resource development in the areas of drug abuse prevention, welfare of senior citizens and transgenders, beggary prevention, and other social defence issues.

**What is the National Institute of Social Defence?**

1. NISD is an autonomous body under the Ministry of Social Justice and Empowerment, Government of India.
2. NISD is a centre to carry out research on social defence.
3. NISD coordinates and liaises between the government and the non-government organisations at state, national and international levels.
4. The institute develops preventive, curative and rehabilitative tools, programmes and policies in the field of social defence, and also undertakes research, training, consultancy, documentation and publication in the field.

The mandate of the institute is to provide inputs for the social defence programmes of the Government of India through training, research and documentation

Original, unpublished research papers, conceptual articles, and case studies relevant to the conference theme and sub-themes are invited.

## Abstract Submission: LAST DATE- 30TH JULY, 2025

- Interested participants are required to submit an abstract of not more than 300 words, along with 3-5 keywords. The abstract should clearly state the research question, methodology, main arguments, and potential contribution to the conference theme. Abstracts must be accompanied by a cover page including the title of the paper, name(s) of the author(s), affiliation(s), email address(es), and contact number(s).

## Full Paper Submission: LAST DATE- 7th August, 2025

- Upon acceptance of the abstract, authors will be invited to submit their full papers. Full papers should ideally be between 5,000 and 8,000 words, including footnotes and references. Papers must follow a consistent citation style APA format. Formatting guidelines; Font- Times New Roman, Spacing-1.5 for body and 0.5 for footnotes, Font size; 12-body, 14- Title and 10-Footnotes

## Submission Process:

Submissions must adhere to the specified deadlines.

## Review Process:

- All submissions will undergo a very stringent and rigorous editorial process by a panel of experts. Acceptance of abstracts and full papers will be based on relevance, originality, rigor, and contribution to the conference theme.

**Kindly Note:** Any manuscript depicting a similarity/plagiarism index higher than 10 percent (as per UGC Guidelines) shall stand rejected and shall not be entitled to be put in the editorial process.

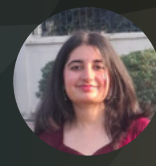
