The Right to Information as a fundamental right was provided to every citizen of the country by RTI Act 2005 considering several necessities of the hour: to ensure transparency, accountability and openness from the public authorities; to prevent misuse of power and corruption; establishing a healthy democracy and to bring about a responsive, healthy and corruption free government.
