# ABOUT RGNUL



The Rajiv Gandhi National University of Law (RGNUL), Punjab, was established by the State Legislature of Punjab by passing the Rajiv Gandhi National University of Law, Punjab Act, 2006 (Punjab Act No. 12 of 2006). The Act incorporated a University of Law of national stature in Punjab, to fulfill the need for a Centre of Excellence in legal education in the modern era of globalization and liberalization.



## INFRASTRUCTURE



Rajiv Gandhi National University of Law, Punjab is a residential university operating at its campus in Sidhuwal, Patiala-Bhadson Road, Patiala (Appx: 47.30 acres). All students live in hostels (separately made blocks of hostels for boys and girls). The University provides all required services to students on campus, including a health centre, a bank, a post office, a canteen and cafeteria, a stationery and book shop, a laundry service, a gym, and other sports facilities. The Guest House, VIP Guest House, twenty-eight faculty houses, thirty-two non-teaching residences, and sixteen houses for class IV employees are all fully occupied. The entire campus is connected by well-kept roadways and is surrounded by lush greenery. More than 66% area of the campus is under green cover.



# CURRICULUM

RGNUL offers a rigorous academic curriculum for its students, which comprises of 36 core courses and 24 elective subjects. Fourth year onwards, students are given an option to choose among a specialisation in Business, Criminal, International or Constitutional laws.

## MARKING SCHEME

The evaluation system at RGNUL comprises of a rigorous system of examination, project assignments, viva voce, presentations and moot courts. At the end of every semester, each student is marked out of a total of 100 for every subject which factors in their examination (theory and practical components) aggregating 600 marks for every semester.

## ACADEMIC INITIATIVES

### Law Practicum Series

The law practicum series was introduced to ensure that proper technical and industrial-specific knowledge is imparted to the students. Through intensive teaching and practical real-world examples of the subject, it is intended to enhance understanding and bridging the gap between substantive legal knowledge and the problems that are faced in the real world. Law practicum includes a pedagogy wherein industrial experts and legal practitioners in the specialised field are invited to deliver lectures to students on specialised and advanced subjects. It portrays that the students are not bound by the straight-jacket syllabus that is present in the curriculum and can think out of the box.

#### OBJECTIVE

To promote better understanding of the profession by bridging the gap between the academic realm and the real world.

#### STRENGTH

Practical experiments is retained in the memory for a longer time and know-how exactly something is work in reality.

### Interdisciplinary Teaching

A lawyer is a jack of all trades but a master of none and so is legal teaching and academics. Keeping this in mind, interdisciplinary teaching has been introduced to ensure that there is no stagnation of knowledge and that various methods of teaching are being experimented with and implemented to amplify convergent understanding by using a blend of different styles of pedagogy. Interdisciplinary teaching at RGNUL focuses on converging the concepts of social sciences with various fields of Law. This empowers the students to grasp the practical approach to the field and gauge impressions of their expertise and interest.

## Research Outcome Dissemination Series (RODS)

The Research Outcome Dissemination Series (RODS) is one of the initiatives by RGNUL to ensure that high-quality research. RODS was introduced for enhancement, dissemination, and amplification of quality research and application of innovative findings with respect to real-world situations. It takes into consideration the interdisciplinary and quality legal and factual understanding of the situations via collaborations and partnerships with different organisations including private and public organisations such as government departments, academic institutions and international and national think tanks, and other research institutions. The most striking feature of RODS is that it includes participation from all levels including agencies, research scholars, students, and other professionals. Each session spans across half an hour where the initial half is devoted to understanding the research questions and the rest half-open to the discussion.

### Inspiring Legal Research

Legal research in India is gradually improving. Some high - quality research work is being done in Law and allied fields in India. However, these researches are not getting a suitable platform to reach its target audience. As a result of this, the beneficiaries of this research remain unaware and at a loss. In order to address this situation, RGNUL has launched an initiative to showcase significant research in the field of law and related subjects through the Research Outcome Dissemination Series (RODS).

### Structure

Every session of the series shall comprise of a one and half hour duration, where the initial half of the 45 minutes is reserved for faculty moderated discussion and the latter half for the open discussion on the Process, Methodology and Report of the research. Thus, every session of the series will provide a common platform not only for disseminating the outcome of the research but also to showcase the entire research process and research methodology, which will inspire the audience to engage in research and enrich their experience.

### RGNUL BOOK SERIES ON CORPORATE LAW AND CORPORATE AFFAIRS (RBS)



The acclaimed RGNUL Book Series on Corporate Law & Corporate Affairs (RBS) is a bi-annual, student run, peer reviewed book series established in the year 2016. It falls under the aegis of the Centre for Business Laws and Taxation (CBLT). The book series aims to focus on contemporaneous legal issues related to General Corporate Governance, Banking, Financial Services and Insurance, Consumer Products and Retail, Sports, Dispute Resolution, Communications (Telecom & Broadcasting), Competition Law, Mergers & Acquisition, Taxation, etc. with contributions from practitioners, legal academicians, professionals, undergraduate and postgraduate students, etc. Since its inception, RBS has successfully published four volumes titled 'International Taxation', 'Corporate Regulations', 'Corporate Governance', including their latest volume on 'Mergers & Acquisitions' (2021). Their upcoming (fifth) volume is centred around 'Competition Law' and is under review currently.

### RGNUL STUDENT RESEARCH REVIEW (RSRR)



RGNUL Student Research Review (formerly known as the RGNUL Student Law Review) was constituted and registered in the year 2013. RSRR is a bi-annual, student run, and blind peer reviewed, flagship law journal based at Rajiv Gandhi National University of Law, Punjab. The RSRR Journal strives to publish comprehensive treatments of subjects ("articles"), written by law students and industry experts on contemporary issues, from different areas of law. RSRR aims to stimulate discussion on contemporary and less explored issues through the themes chosen for the Journal as well as the monthly blogs. It seeks to create a platform for academicians in the field and stakeholders of the industry to express their views and opinions alike and share insights to their experiences. As a research review, RSRR not only attempts to bring about critical analysis of laws but also of policies, rules or guidelines involved in the chosen issue. RSRR invites and encourages authors to put forth constructive solutions to bridge the gap between theory and practicality. In the short period since its constitution, RSRR has been ranked among the top 35 constitutional law blogs by Feedspot and has featured as one of the 13 Indian Law Journals in the 2019 list of W&L Law Journal Rankings.

### RGNUL FINANCIAL AND MERCANTILE LAW REVIEW (RFMLR)

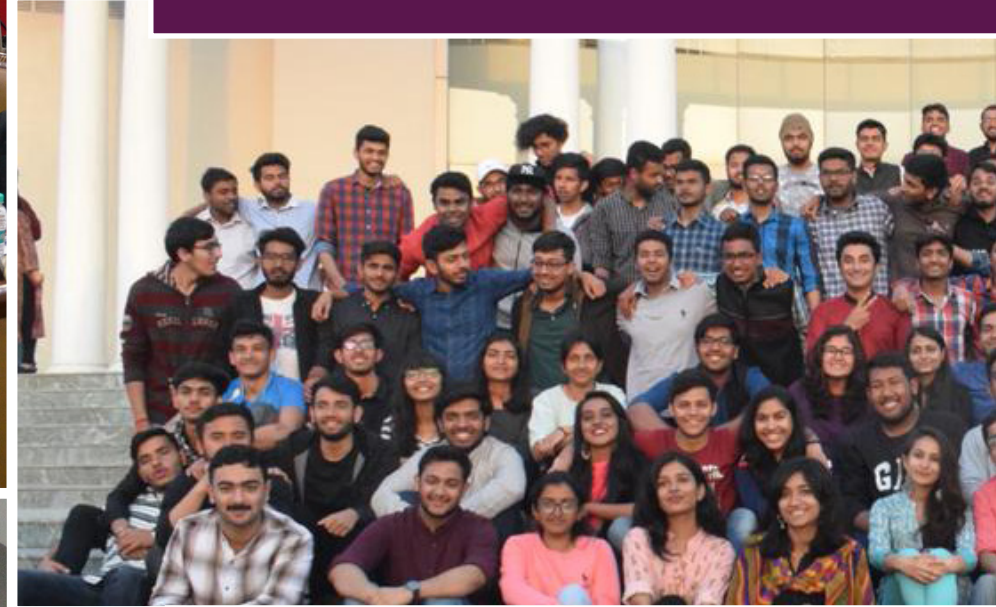


RFMLR is a student-run, bi-annual, double-blind peer-reviewed journal published by the Rajiv Gandhi National University of Law, Punjab established in the year 2016. It is one of the flagship publications of RGNUL and is run and managed by a student Editorial Board. The journal gives an opportunity to the legal academia, legal professionals, and law students to contribute cuttingedge, doctrinal, theoretical, and empirical research in the field of business and commercial laws. RFMLR is indexed on SCC Online and has been ranked the 6th most accessed Law Review in India on the platform. The Editorial Board has published seven volumes comprising two bi-annual issues each, and two Special Issues till date. Further, the Board also published Volume VIII Issue I of the Journal recently, and is currently in the process of publishing Volume VIII Issue II. Further, the Editorial Board also operates the RFMLR Blog on its website. The Editorial Board also publishes a monthly Newsletter (Au Courant) that covers the latest happenings in different sectors of commercial laws, in addition to interviewing many noted practitioners and academics in order to understand their views on the pressing issues of the day. Au Courant is the flagship newsletter of the RGNUL Financial and Mercantile Law Review (RFMLR), published on a monthly basis.
