ABOUT THE UNIVERSITY

Rajiv Gandhi National University of Law (RGNUL), Punjab was established by the State Legislature of Punjab by passing the Rajiv Gandhi National University of Law Punjab Act, 2006 (Punjab Act No. 12 of 2006). RGNUL started functioning from its Headquarters - Mohindra Kothi, the Mall, Patiala w.e.f. 26 May 2006. The University acquired approval of the Bar Council of India (BCI) in August 2006. The University got registered with the University Grants Commission (UGC), New Delhi under Section 2(f) of the University Grants Commission Act, 1956 and also got recognition under Section 12-B of the said Act. The RGNUL is a regular member of Association of Indian Universities (AIU), New Delhi and several other prestigious

national and international organizations / institutions.

The main campus of the University is at Sidhuwal, Bhadson Road, Patiala spread in an area of 50 Acres of land. The *state-of-the-art* Campus has an Administrative-cum-Academic Block, separate spacious Library Building, Auditorium, Sports Complex, Boys and Girls Hostels, Guest House, Community Hall, Health Centre, Residences, Stadium and other facilities. The University is fully residential. All RGNUL Boys and Girls students are residing at the University Hostels at the Campus. The Hostels provide all modern amenities including air conditioning of each room. Teachers are also residing in their Faculty House at the Campus.



RGNUL has a well equipped computerized Central Library in addition to the specialized libraries of our various Research Centres. There are three advanced Computer Labs with high end computers and leased line internet connectivity. The whole RGNUL Campus is wi-fi enabled which is also extended to the respective hostels round the clock.

The University has also set up Centres of Advance Study at its campus. These are: Centre for Advanced Study in Criminal Law (CASCL); Centre for Consumer Protection Law and Advocacy (CCPLA); Centre for Advanced Study in International Humanitarian Law (CASH); School of Agricultural Law and Economics (SALE); Centre for Advanced Study in Labour Welfare (CASLW) and School of Social Sciences and Inter-Disciplinary Studies (SSSIS).

Keeping in mind the need to propagate the concept of social engineering and social lawyering, RGNUL has taken initiative through many outreach programmes like: RGNUL Enabling Unit (REU); RGNUL Institute of Competitive Examination (RICE); Centre for Advanced Study in Human Rights (CASHR); Directorate of Distance Education (DODE); RGNUL Legal Aid Clinic (RLAC).

The School of Law of the Indira Gandhi National Open University (IGNOU), New Delhi has set up a Programme Study Centre at RGNUL, Patiala. RGNUL Legal Aid Clinic has also been established at the RGNUL Campus under the aegis of Punjab State Legal Services Authority. The University has entered into MoU with many National / International institutes for academic collaboration.



THE CAMPUS

LIBRARY

Presently housed in "Academic Block" of the university, the air conditioned university library is an example of excellence. With world class library services and rich collection of books and journals, this computerized Wi-Fi library has on its shelves more than 28, 000 volumes which include a

libraries in India which has implemented Radio Frequency Identification (RFID) technology. Hon'ble Mr. Justice A. K. Sikri, the then Chief Justice of Punjab & Haryana High Court and Chancellor, RGNUL, inaugurated the Radio Frequency Identification Technology (RFID) at this Library on 24th January, 2013. RFID technology not only



comprehensive array of legal resources in both print and electronic formats. In addition, 126 periodicals are also subscribed.

Prized collection of the library includes online version of LexisNexis India, LexisNexis Academics, Manupatra, Westlaw India, SCC Online, Hein Online, LII of India, Corporate Law Advisor, etc. In print form the RGNUL Library has updated volumes of American Journal of International Law, Harvard Law Review, International Legal Materials, The Digest, Words and Phrases, Encyclopedia of Precedents, American Jurisprudence, Cox's Criminal Cases, Halsbury's Law of England and the Law Reports. The RGNUL library is one of the few

facilitates auto issue and return of books at unmanned counter but also helps in effective shelf management. A very prestigious project of scanning rare books has been started with sophisticated scanner BOOKEYE-4.

The Library would soon be shifted to an independent, air-conditioned ultramodern building during next academic session. With a seating capacity for 300 readers, the *state-of-the-art* building has moot court lab, conference hall, computer labs and space for Centres of Advanced Studies. Outer Reading Hall will be kept open 24x7 for the readers.

IT FACILITIES

The University has established three fully air conditioned computer labs with 140 computers with latest configuration and high speed internet connectivity at RGNUL New Campus, Sidhuwal, Patiala. First lab is equipped with 54 HP computers. The second lab has around 70 Hi-tech Apple computers and in the third Lab there are 16 DELL computers.

To provide the best use of IT in the field of education the University has installed Interactive Boards, Projectors and Multimedia Podium in each class room of RGNUL new campus. The software supplied with the interactive whiteboard allows the teacher to keep notes and annotations in an electronic file for later distribution, either on paper or through a number of electronic formats. The University IT department provides guidance to the students, faculty and non-teaching staff in attaining expertise in operating computers. The academic curriculum of the University is largely oriented towards the use of latest technology.

The University is having 1Gbps connectivity for its campus through BSNL under NMEICT project. With the implementation of this mission, the RGNUL has become a part of National Knowledge Network (NKN) through BSNL. This project provides econnectivity to the students and the teachers. It enables students to communicate with other Universities. The RGNUL campus is fully Wi-Fi enabled campus with access to internet, intranet and e-mail on 24x7 basis.

The Single mode/multi-mode fiber-optic cabling has been laid over a distance of about 2 km extending to various university buildings at the Campus. Now all the Hostels, Faculty Residences, Academic Block, Administrative Block, Facility Area and Guest House are connected with optical fiber backbone. The newly established Server Room is equipped with the latest Blade Server, Central Core Switches, and Security software. All the IT facilities established in the various buildings of the University are managed through the single Server Room.



THE MOOT COURT HALL

Mooting is one of the prime academic activity promoted at RGNUL. It is an endeavour of the University to encourage its students to participate in National and International Moot Court Competitions. The university provides conducive



environment similar to real young minds to focus on court room proceedings at various moots. The University is in the process of furnishing its Moot Court Hall which will be fully equipped to conduct national and international Moot Court Competitions.

THE HOSTELS

The RGNUL has constructed all the eight hostel blocks. Four hostels blocks each, for boys and girls

are fully equipped with independent mess / dining facilities.

Each Hostel room along with men area are fully-air-conditioned. It is ensured that the hostels have 24 hour water supply and round the clock generator backup. All the hostels are WiFi enabled. An aquaguard system is attached to each water-cooler to ensure 24-hour clean water supply. Proper hygiene and sanitation is maintained by the dedicated house keeping service. All the hostels have proper security system for the safety and well being of the students.

The Hostel rooms are furnished with curtains, box type bed(s), study table(s), study chair(s), books shelve(s) etc. Every room has been provided with wardrobe(s) having sufficient storage capacity; which are fitted with locker for safe custody of valuables. The rooms are made for both single occupancy and double-occupancy. Hostels have rooms for specially abled students with attached wash-rooms to provide adequate facilities for them. Every hostel has recreational facilities for the student. Every block has three commonrooms. These common-rooms are equipped with Table-Tennis Boards, Televisions, Carrom Boards





etc. Badminton court, basketball court and volleyball court have been constructed in the sports area adjoining the hostel buildings.

UNIVERSITY GUEST HOUSE

The guest house building is a double storey building. There are four suites and twenty eight rooms. The guest house has a spacious dining hall with kitchen, V.I.P. Lounge, Mini Conference Hall and a Waiting Area. All the suites and rooms are air conditioned and fully-furnished.

UNIVERSITY HEALTH CENTRE

The University Health Centre (UHC) has been setup at the University. UHC has medical facilities for indoor admissions, minor surgeries, resuscitation equipment, vaccinations, sterilization of equipment and stock of medicines for routine and emergency ailments. It functions round the clock for all days. In addition to medical facilities diligent efforts are undertaken by the UHC towards Gender Education, Acquiring Life Skills, Prevention of Addictions and Substance Abuse, Prevention of

Sexually Transmitted Diseases, General Hygiene and Health; and Psychosocial issues etc. UHC also has the onus of conducting routine health check up of students and staff, especially of the staff who handles food in the mess and canteen. Surveys on vaccination status are routinely conducted and necessary measures undertaken. The UMC has an ambulance for emergency shift the patient to the specialised hospitals in the city. The University has entered into an MoU with the prominent multispeciality Hospital of Patiala to counter any medical emergency.

OUR GYMNASIUM AND SPORTS ACTIVITIES

The RGNUL Campus has a fitness centre, designed



exclusively for the young students. The gymnasium provides a great way to be fit and stay motivated. The gymnasium is manned by qualified trainers. In addition to Gymnasium, the students have been provided with other sports facilities which includes cricket Football, Table Tennis, Volley Ball, Basket Ball and Badminton and tracks. The students of RGNUL are encouraged to take active part in the sports activities. They take part in inter and intra university sports events which are organised from time to time.

SCHOOL OF LAW (SOL)

Programme Study Centre of IGNOU

RGNUL has established region's first School of Law (SOL) of IGNOU in its premises. The School of Law established in 2005 by the Indira Gandhi National Open University (IGNOU) aims at achieving excellence in the field of legal education through distance education mode. SOL has initiated various Post Graduate Diploma and Certificate Courses upcoming in various area of law. The courses offered by IGNOU's School of Law are: Post Graduate Certificate in Cyber Laws (PGCCL), PG Certificate in Patent Practice (PGCCP), Post Graduate Diploma in

Intellectual Property Rights (PGDzIPR), Post Graduate Diploma in Criminal Justice, Certificate Programme in Consumer Protection (CPP), Certificate Programme in Human Rights (CHR), Certificate in Social Work and Criminal Justice System (CSWCJS), Diploma in Paralegal Practice (DIPP). These programmes are meant for Law Students, Advocates, E-Commerce Professionals,

Company Secretaries, Charted Accountants, Police Officials, Data Entry Operators, Information Technology Professionals, Academicians and Researchers. Any graduate in any discipline or a student of fourth and fifth year of Five Year integrated LL.B. course is also eligible to seek admission in the above mentioned postgraduate diploma courses, being run by School of Law.



THE COURSES

The RGNUL offers the following Courses:

- B.A.LL.B. (Hons.) Five-Year Integrated Course
- LL.M. (One-Year Post Graduation)
 Degree Programme
- 3. Research Degree Programme
 - (i) Ph.D. in Law
 - (ii) Ph.D. in Social Sciences with Law(Details are in the RGNUL Regulation Booklet)

RGNUL offers B.A.LL.B. (Hons.) Five-Year Integrated Programme having Social Sciences, Language and Law subjects. The Social Sciences and Language papers are taught in the first three years of study alongwith compulsory law subjects. Social Science subjects are Economics, History, Political Science and Sociology as major and minor subjects. The course offers papers in English and Foreign Language and Law subjects in the first three years of study. All subjects are compulsory in the first three years. However, in the fourth and fifth year, students are offered optional specializations in four different streams, viz., Business Law, Criminal Law, Constitutional Law and International Law. The successful students are awarded Honours Degree with specialization.

RGNUL follows the Semester System. The teaching methodology includes extensive and intensive class room teaching with emphasis on participative learning. The Course Curriculum includes assignments, seminars and project

work. The thrust of the course is not just on learning but also on professional training.

Eligibility for Admission:

The admission shall be made exclusively on merit in the Common Law Admission Test (CLAT). However, to be eligible to appear in CLAT-2014, a candidate should have obtained a Senior Secondary School/Intermediate (10+2) or its equivalent certificate from a recognised Board with not less than 45% marks in aggregate (40% in case of SC/ST candidates) and should be below 20 years of age as on 1st July 2014 (22 years in case of SC/ST and PWD candidates).

Candidates appearing in or awaiting results of the qualifying examination held or being held in March/April 2014 may also apply and appear in the Common Law Admission Test (CLAT) provisionally, subject to the condition that they shall produce the proof of having passed the qualifying examination with the prescribed percentage of marks at the time of their interview/counselling.

The candidature of those who do not pass the qualifying examination with the requisite marks and/or fail to produce result on the date of interview/counselling, or those who get compartments/re-appear in any subject(s) in the qualifying examination, shall be cancelled and subsequent securing qualifying marks shall not be considered for admission in any case.

Intake and Reservation:

The total number of seats for the B.A.LL.B.(Hons.) Five-Years Integrated Course shall be One

Hundred and Twenty (120). Division of the seats shall be as under:

NOTES:

- (i) The candidates applying in the SC/ST category are required to submit the caste certificate from the Competent Authority.
- (ii) Persons with Disability (PWD) category seeking benefit of reservation of seats are to submit minimum 35% Disability Certificate from the Medical Specialist of a Government Hospital.
- (iii) The candidature of the Punjab Resident Category shall be determined on submission of an affidavit and certificate as per the Punjab Government Letter Number 1/3/95-3PP II/9619 dated 06-06-96 as amended vide the Punjab Government Department of Personnel and Administrative Reforms Letter No. 11/3/95-3PP-II/80 dated 01-01-99 (Further details and relevant formats of affidavit and certificate(s), are with the admission form).
- (iv) To claim seat in the category of the Residents of Village Sidhuwal, District

Patiala, the candidate should have ancestral origin in Village Sidhuwal. A candidate shall not be treated as a resident of village Sidhuwal with Ancestral Origin if he/she or his/her parents have migrated to settle in Village Sidhuwal or is a resident of any colony developed in the land of village Sidhuwal. The candidate must otherwise be eligible for admission and should have qualified the CLAT. Inter-se priority shall be determined as per merit of the CLAT and rules thereof. The candidates claiming admission as resident of Village Sidhuwal are required to submit a residence certificate issued by the competent authority. Candidates shall also submit a declaration of their ancestral residence duly verified by the Sarpanch of Village Sidhuwal.

(v) The candidates in the categories (a) to (f) and (h) in the table above must satisfy the conditions of eligibility and must qualify the Common Law Admission Test (CLAT) 2014.

(vi)

Admission to the category of 'Foreign Nationals' (g) possessing the citizenship of a country other than India shall be Direct Admission on the basis of the *inter-se* merit of the qualifying examination, after due verification of the equivalence and eligibility and also on the basis of the interview to ascertain proficiency in English Language, overall academic record and suitability. All Foreign National Candidates must apply directly to the Registrar RGNUL at Sidhuwal Campus, Patiala in the RGNUL prescribed Admission Form (available in RGNUL Prospectus and also at

the RGNUL Website) alongwith with a Demand Draft of Rs. 1500/- in favour of Registrar RGNUL, payable at Patiala. The candidate shall also enclose the supporting documents.

- (vii) The allocation of the candidates admitted to RGNUL, Punjab by the CLAT Authority through the Centralised Admission process shall be provisional subject to verification of original certificates / testimonials and documents by RGNUL. Therefore, candidates are required to submit admission form available with the RGNUL Prospectus alongwith the attested copies of the documents/certificates.
- (viii) The Candidates are required to produce original Certificates / Documents on the date of the interview/ counselling. Failure to produce Certificate / Documents in original shall result in cancellation of their candidature.
- (ix) Seats for Kashmiri Migrants and Supernumerary Quota Seats for residents from Jammu and Kashmir: There shall be six additional seats (5% of total seats) in the B.A.LL.B. course for the wards of Kashmiri Migrants and two Supernumerary Quota Seats for residents from Jammu and Kashmir. Such candidates shall appear in CLAT. The admission shall be on the basis of inter se merit in the respective category. The candidate shall be required to produce the authentic documentary proof of belonging to the said category. The other

eligibility conditions shall remain the same as that of the general category. In case any of the seat(s) remain(s) vacant in this category such vacant seat(s) shall not be converted into the General Category.

- (x) Conversion of reserved seats into general category – In case of non-availability of candidate in reserve category, the vacant seat(s) shall be converted as under:
 - (i) On non-availability of a ST candidate, the seat(s) shall be converted into the SC Category.
 - (ii) On non-availability of a SC candidate, the seat shall be converted into the General Category.
 - (iii) On non-availability of a person with disability the seat shall be converted into the General Category.
 - (iv) On non-availability of Foreign Nationals, the seat(s) shall be converted into the General Category.
 - (v) On non-availability of the Punjab Resident category candidate, the seat(s) shall be converted into the General Category.
 - (vi) On non-availability of ancestral resident of Sidhuwal category candidate, the seat shall be converted into the General Category.



LL.M. (ONE-YEAR POST-GRADUATION PROGRAMME)

The RGNUL offers one-year LL.M. Post Graduation Course with specialization in Business Law, Constitutional Law, Criminal Law and International Law (Specialization will be offered subject to the condition of minimum five students opting for the same).

Eligibility for Admission:

The Admission shall be based exclusively on merit in the Common Law Admission Test (CLAT). The candidate who has passed the LL.B./B.A.LL.B. Degree examination from Rajiv Gandhi National University of Law or any other University whose degree is recognized by RGNUL, with minimum 55% marks (50% marks for SC/ST Category students) shall be eligible for admission to the course.

Candidates appearing in/awaiting results of the qualifying examination being held in April/May 2014 may also apply and appear provisionally for the Admission Test, subject to the condition that they shall produce the proof of having passed the qualifying examination with the minimum prescribed marks at the time of interview/counselling. However, the candidature of those who do not clear the qualifying examination with the requisite marks and/or fail to produce result on the date of interview/counselling, shall be cancelled and subsequent securing of qualifying marks shall not be considered in any case.

Intake and Reservation:

The total number of seats for the LL.M. Course are Forty (40). Division of seats shall be as under:

NOTES:

- (I) The candidates applying in the SC/ST category are required to submit the caste certificate from the Competent Authority.
- (ii) Persons with Disability seeking benefit of reservation of seats are to submit minimum 35% Disability Certificate from the Medical Specialist of a Government Hospital.
- (iii) The candidates in the categories (a) to (d) and (f) in the table above must satisfy the conditions of eligibility and must have qualified the Common Law Admission Test (CLAT) 2014 (Post Graduation).
- (vi) Admission to the category of 'Foreign Nationals' (e) possessing the citizenship of a country other than India shall be the

Direct Admission on the basis of the interse merit of the qualifying examination, after due verification of the equivalence and eligibility and also on the basis of the interview to ascertain proficiency in English Language, overall academic record and suitability. All Foreign National Candidates must apply directly to the Registrar RGNUL, Sidhuwal Campus, Patiala in the RGNUL prescribed Admission Form (available with the RGNUL Prospectus and also at the RGNUL Website) alongwith with a Demand Draft of Rs.1500/- in favour of Registrar RGNUL, payable at Patiala. The candidates shall also enclose the supporting documents.

- (v) The allocation of the candidates to RGNUL, Punjab, by the CLAT Authority through the Centralised Admission process shall be provisional subject to verification of the original certificates / testimonials and documents by RGNUL. Therefore, candidates are required to submit admission form available with the RGNUL Prospectus alongwith the attested copies of the documents/certificates.
- (vi) The Candidates are required to produce original Certificates/Documents on the date of the interview/ counselling. Failure to produce Certificate / Documents in original shall result in cancellation of their candidature.
- (vii) Seats for Kashmiri Migrants and Supernumerary Quota Seats for residents from Jammu and Kashmir: There shall be

two additional seats (5% of total seats) in the LL.M. course for the wards of Kashmiri Migrants and two seats as Supernumerary Quota Seats for residents from Jammu and Kashmir. Such candidate shall come through CLAT. The admission shall be on the basis of *inter se* merit in the respective category. The candidates shall be required to produce the authentic documentary proof of belonging to this category. The other eligibility conditions shall remain the same as that of the general category. In case the seat remains vacant, it shall not be converted into the General Category.

- (ix) Conversion of reserved seats into general category – In case of non-availability of candidate in reserve category, the vacant seat(s) shall be converted as under:
 - (a) On non-availability of a ST candidate, the seat(s) shall be converted into the SC Category.
 - (b) On non-availability of a SC candidate, the seat shall be converted into the General Category.
 - (c) On non-availability of a person with disability the seat shall be converted into the General Category.
 - (d) On non-availability of Foreign National candidates(s) the seat(s) shall be converted into the General Category.

CENTRE FOR ADVANCED STUDIES IN CRIMINAL LAW (CASCL)

RGNUL has established a Centre for Advanced



Studies in Criminal Law (CASCL) to undertake advanced study and research in the emerging areas of criminal law; professional training including sensitisation on application and enforcement of criminal law in a fair and coherent manner; research projects independently or in collaboration with professional organisations at the national and international level; to bring about publications and produce study material on various aspects of criminal law and to organise seminars, workshops and conferences on contemporary and significant issues of criminal law. Under the auspices of the CASCL, the University has already started Post Graduation Programme (LL.M.) in Criminal Law. The Centre has enrolled candidates for the Research Degree Programme (Ph.D.). The Centre aims to contribute to the improvement of administration of criminal justice system as a whole at regional, national and international levels. The major areas of thrust are to bring about reforms in the substantive and procedural criminal law in view of the modern crime scenario; development of sound criminal justice policy and practice; to generate respect

for human rights and rule of law in the administration of criminal justice; training and technical assistance to agencies concerned with administration of criminal justice; renewal of sentencing policies and correctional systems; revamping justice to the victims of crime; and legal aid and speedy disposal of the criminal cases.

CENTRE FOR CONSUMER PROTECTION LAWS AND ADVOCACY (CCPLA)

Another Centre of excellence, namely Centre for Consumer Protection Laws and Advocacy (CCPLA) aims to conduct advanced research in various aspects related to Consumer Protection Law; to provide consultancy in consumer protection litigation by involving students, faculty members and practicing lawyers; to undertake empirical research works in the field of consumer protection; to establish a platform for the purpose of Training the Trainers in order to enhance the potential of the advocates dealing in Consumer Protection Law; to equip thoroughly with the understanding of laws, the analytical ability and functional paradigm of NGOs working and contributing to the consumes cause to provide legal aid to the underprivileged sections of the society in order to promote awareness in the subject; and to render guidance towards 'Public Interest Litigation'. The



Centre plans to start a Post-Graduate Diploma in Consumer Protection Law and Advocacy and further a Post-Graduate Degree in Consumer Protection Law in order to encourage consumer awareness in the society and to give impetus to welfare oriented legislations.

CENTRE FOR ADVANCED STUDIES IN INTERNATIONAL HUMANITARIAN LAW (CASH)

In a short span and primarily due to the efforts of the International Committee of Red Cross (ICRC), Regional Delegation, New Delhi, the University has established a Centre for Advanced Studies in International Humanitarian Law (CASH) with the aim of promoting teaching and research in the area of IHL. RGNUL specialized Centre of IHL aims at disseminating information and awareness about the subject, preparing a data base, carrying out advanced research, organizing conferences, seminars, workshops and sensitization programmes etc. in Humanitarian Law. Centre for Advanced Studies in International Humanitarian Law (CASH) at RGNUL, Punjab, in collaboration with the ICC-India: The Indian Campaign on International Criminal Court organizes Training of the Trainers Programmes (TOT) on International Criminal Law (ICL) from time to time, primarily for the educators and advocates working in the fields of International Law, International Humanitarian Law, International Relations, Human Rights,





Political and Social Work. ICC-India carries antiimpunity campaign and is a project of a Mumbaibased non-profit organization - Women's Research and Action Group. CASH organises annually a National Essay Competition ENSAYO in collaboration with ICRC, New Delhi. The essay competition is based on various facets of Humanitarian Law.

CENTRE FOR ADVANCED STUDIES IN HUMAN RIGHTS (CASIHR)

RGNUL has established a Centre for Advanced Studies in Human Rights (CASIHR) to undertake and promote advanced study and research in the emerging trends relating to this area. With human rights and the principle of respect for human dignity at its core and taking many cross-cutting issues into consideration, the CASIHR aims at promoting, supporting and carrying out advanced studies and interdisciplinary research on numerous issues ranging from good governance to globalization processes, with specific focus on: (i) human rights at regional, national and international perspectives; (ii) human rights in peace and war; (iii) human rights and human security; (iii) trade and sustainable development, (iv) nuclear weapons and use of force by States; (v) environmental degradation; (vi) democracy and rule of law; and (vii) human rights and good governance. In full recognition of the complex national and international issues involved, the



CASIHR intends to approach any study and research from a multi-level and multi-factor perspective. Besides such studies and independent applied research, it ambitiously aims at (i) creating working documents serving as advices to policy makers on human rights governance and public policy issues and (ii) to regularly organize conferences, seminars and debates on the relevant topics. The ultimate objective of the CASIHR is to emerge as a think tank for national and international issues relevant to promotion and protection of human rights and human dignity.

SCHOOL OF AGRICULTURAL LAW AND ECONOMICS (SALE)

The School of Agricultural Law and Economics strengthens the interface of Law and Economics and its relative application to the agrarian economy. In the changing scenario of the globalised world, agricultural development has resulted in socio-economic transformations in the society. In this direction, law has an equally important role to play to bring about stability and enhance efficiency of the economic variables in the present social pattern. SALE is an exclusive Study Centre that aims at providing a broader platform for the analysis of agricultural law and economics, which aims at catering to the problems pertaining to the agrarian sector and its developmental policies. It would encompass the study of the law which focuses on the special rules and exceptions made for agriculture. The Centre aims at enabling the students of law to look into the problems of agriculture and facilitate the application of their knowledge towards a better working rural economy. It also aims at sensitizing the people associated with the planning and development of the rural sector to the legal requirements and legal remedies. The strength of the SALE is its well equipped library, which possesses a diverse collection of books and reports related to agricultural developments and to plan policies at national and international level. Above all, the object of the School of Agricultural Law and Economics is to impart an in-depth knowledge of the agricultural laws and also to undertake research projects on policy framework and its effective implementation.

CENTRE FOR ADVANCED STUDIES IN LABOUR WELFARE (CASLW)

Rajiv Gandhi National University of Law in association with the International Justice Mission (IJM), an International NGO based in Delhi established the Centre for Advanced Studies in Labour Welfare (CASLW) on 1st September 2012. Since its inception, the centre has held various training programmes like Workshop for the public prosecutors of the District Court, Patiala, Workshop on 'Bonded Labour: Prohibitions and Rights' for NGO's, Labour Welfare Officers. Workshops were conducted for students too whereby they were sensitized about the problems of child labour. The Centre has also



launched an Essay Competition sponsored by HCL Inc. on the topic of 'Labour Welfare: Strategies required for the State of Punjab'. The Primary aim of the Centre is to spread awareness for Labour Welfare and empowerment.

SCHOOL OF SOCIAL SCIENCES AND INTER-DISCIPLINARY STUDIES (SSSIS)

Teaching and learning have no limits. Rather it is expected of an educational system to remain dynamic and responsive to every change in the society. Keeping in mind that we are living in a rapidly changing world and even rapidly changing society, education plays a vital role by giving direction to new ideas and attaching meaning to progress. Education promotes not only technical knowledge but also humanitarian values in respective societies. Social scientists have seen unparalleled importance in the times of globalisation as they are called upon to supplement and evaluate critically the various aspects of growth. RGNUL believes that education of humanities and social sciences should be promoted in an inter-disciplinary way so that such learning may contribute to the strengthening of unity, involvement, harmony, honesty, creativity, critical and analytical thinking, and commitment to accept change and establish healthy relations with international community. The School of Social Sciences and Inter-Disciplinary Studies (SSSIS) has been





established at RGNUL to work at national as well as international level for higher level of studies. The SSSIS has already received a good response from educational institutions of India and from abroad for collaborative work.

RGNUL ENABLING UNIT (REU)

In consonance with the XIth Plan guidelines of the University Grants Commission, RGNUL has established a unit named as RGNUL Enabling Unit as per UGC policy. The main objective of the Enabling Unit is to develop awareness in higher education system and also to provide necessary guidance and counselling to differently abled persons and to generate legal awareness on disability issues. The Unit aims to pursue the cause and make efforts to foster opportunities for the differently abled persons, so that the real stakeholders are benefitted. The unit aims at creating an empowering legal discourse on disability rights with active participation of persons with disabilities, through the medium of research, training, discussion and consultation.

RGNUL INSTITUTE FOR COMPETITIVE EXAMINATIONS (RICE)

RGNUL Institute for Competitive Examinations (RICE) is a centre for preparing the aspirants for the Central and State Civil Services. The students of the university are guided in the course of their

preparations for various state and central civil services competitive examinations. RICE has a separate library equipped with all relevant study material and books required for competitive exams. The special feature of this library is the availability of the reports published by national/international organizations and offices. This library is featured with a strong database on almost all fields of administration like Agriculture, Social Human Development, Human Development Index (HDI), Investments Details, Infrastructure, etc. Another aspect of academic and cognitive engineering on which RICE emphasizes is the development of the 'Research Aptitude' amongst the students.

DIRECTORATE OF DISTANCE EDUCATION (DODE)

Directorate of Distance Education (DODE) aims at imparting legal knowledge amongst learners from all over the country. DODE has been established specifically to put forward a functional response to universalisation of legal profession. Degrees and Diplomas in fields like Consumer Protection Laws and Advocacy, Law and Medicine, Environmental Law and International Humanitarian Law, are proposed to be undertaken by the DODE. DODE shall operate through the most contemporary modes of teaching and learning. The students shall be provided with a detailed 'Study Material' related to the contents and this study material shall entail research based exploration of the themes concerned. The teaching and the learning techniques shall be formulated specifically taking into consideration the regional differences of the students getting enrolled from various states and nations. Special emphasis shall be put on the pre-requisites like language, time duration and time management, postal

obligations, response and assessment mechanisms, etc. On the whole, the main target of the DODE shall be to impart education transcending the regional and the national boundaries.

RGNUL LEGAL AID CLINIC (RLAC)

The RGNUL Legal Aid Clinic has been established at the RGNUL Campus under the aegis of Punjab Legal Services Authority on 22 April, 2011. The importance of Legal Aid and Awareness Campaigns as a mechanism for social progress is something that has been repeatedly stressed upon by the Government of India. In the backdrop of poverty and inequality, legal aid is an effective way towards attainment of the ideals of 'Social, Economic and Political' Justice that are enshrined in our Constitution under the Directive Principles of State Policy. RGNUL CODE OF CONDUCT

RGNUL aims at securing excellence in the field of professional legal education and research. It imbibes the qualities of learning and research in the students; a commitment to ethics; diversity; public interest; and social justice. The University takes a pro-active position on all matters relating to professional and appropriate Code of Conduct on the part of the entire University students community, faculty and non-teaching staff. There is a general expectation that all members of the RGNUL family will observe decorum in all their relations with each other. The University also requires strict observance of the statutory provisions in this regard.

In furtherance of its commitment to an environment of honesty, fairness and mutual respect, RGNUL takes serious cognizance of the acts of academic / professional misconduct that include cheating on academic exercises, plagiarism, misrepresentation and interference of any kind in the access of fellow students to University services, among others.

There is no scope for the students to indulge in

any type of political activities inside or outside the campus. Evidence of any political activity inside the campus is considered as an act of gross indiscipline and shall be very strictly dealt with. RGNUL is a residential University. Every student shall remain on the campus during the study hours and he / she shall not leave the campus without prior permission. The minimum commended core values of the University include the following:

- (1) Truthfulness;
- (2) Non-Violence;
- (3) Compassion;
- (4) Equal human dignity and equal status of all people;
- (5) Freedom for all, including their freedom of thought, belief and their freedom to dissent;
- (6) Pluralism and pluri-versalism;
- (7) Professionalism; and
- (8) Safeguarding the interests of the community and avoiding harm to the community.

HOSTEL RULES

- A student is not allowed to stay in hostels during the class hours.
- 2. A student is not allowed to remain absent from the hostels overnight without the written permission from the warden.
- 3. A student is not allowed to take any guest to his/her hostel room.
- 4. Hostel residents are not allowed to keep motor vehicles at the hostels.
- Smoking, consumption of alcohol or other intoxicants are strictly prohibited.

- Contravention of the rule shall invite strict disciplinary action.
- 7. The students are not allowed to keep or use any electrical appliances in the hostel rooms.
- 8. The students shall be responsible for maintenance of cleanliness in and around their hostel rooms. Spoiling / defacing of hostel property / building shall be penalized and may also lead to community fine.

IMPORTANT INSTRUCTIONS FOR THE STUDENTS

- (1) All the students are required to be in the prescribed Uniform on every Tuesday and Friday.
- (2) A student is expected to be in formal trousers and collared shirts on all other working days except for Saturday
- (3) Chappals and floaters are strictly prohibited. Closed shoes for boys and girls are mandatory.
- (4) A fine of Rs. 50/- per discrepancy shall be imposed on the student violating any one of the above rules.

- (5) The Mid-Term exam results along with the attendance of the student shall be displayed in the months of October and March respectively and also dispatched to his/her parents.
- (6) Smoking and drinking are strictly prohibited. Violation shall lead to strict disciplinary action.
- (7) Mobile Phone and Laptop are strictly prohibited in the classrooms. Violation of this rule, will fetch strict disciplinary action.



RGNUL REGULATIONS ON CLASS ATTENDANCE

- (1) Every student shall be required to attend minimum 85% lectures in each subject during the semester.
- (2) If any student falls short of attendance he/she shall not be allowed to appear in the end semester examination. Such student may be allowed to appear in repeat/supplementary examination on attending deficit lectures through special classes arranged for detained students on payment of prescribe fee.
- (3) Benefit of additional lectures shall be given to those students participating in Moot Courts, Debates, Quiz Competitions, Cocurricular Activities, Blood Donation Camps, Other Competitions/Functions representing the University.
 - Provided that such students must have actually attended minimum 65% lectures delivered to that class.
- (4) (i) In case of serious ailments when a student is admitted as an in-patient in a clinic/hospital or otherwise confined to bed the number of classes missed will be deducted from the total classes held and attendance shall be calculated accordingly.
 - Provided such student must have actually attended at least 50% of the lectures delivered to that class without the aforesaid relaxation.
 - (ii) The students are required to submit their medical certificate, issued by a qualified doctor who administrated the treatment, immediately on joining University after their illness/ confinement, to be duly countersigned by the University Medical Officer.
 - (iii) Subsequent submission of medical certificate shall not be considered for medical leave.
- (5) The Vice-Chancellor shall constitute a Condonation Committee to recommend condonation/addition of attendance as per rules.

- (6) The student who has 70% or above attendance but less than 85% may be allowed to appear in the examination by the Vice-Chancellor on the recommendation of the aforesaid Committee subject to payment of fine @ Rs. 50 per percentage of shortage from 85% of aggregate attendance of all subjects taken together.
- (7) Subject to the provisions in rules (3) and (4) above, a student with less than 70% per cent of attendance shall not be allowed to appear in the End-Term Examination.

 Provided that the Vice-Chancellor may consider extreme cases of hardship on the recommendation of the Condonation Committee referred to rule 5.5 and allow a student to appear in the examination. Cases so allowed are to be put before the Executive Council at its next meeting for information.
- (8) In case of late admission the attendance shall be counted as under:
 - (i) From the date of admission for the first vear class.
 - (ii) For other classes a student shall be deemed to have been admitted from the scheduled date of commencement of classes or one week of the date when he/she becomes eligible for admission, whichever is later, irrespective of date of deposit of fee.

NOTE (A)

- (I) In exceptional genuine cases, where the hospitalization is not necessary, the Committee will accept Medical Certificate from a qualified Medical Practitioner and the same must be endorsed by the Medical Officer of the University.
- (ii) The decision of the Committee on the acceptance or otherwise of the Medical Certificate produced by the student shall be final.
- (iii) In case it is found that any medical certificate submitted is false disciplinary action shall be initiated.



ABSOLUTE NO TO RAGGING

"Ragging" means causing, inducing, compelling or forcing a student, whether by way of a practical joke or otherwise, to do any act which detracts from human dignity or violates his / her person or exposes him / her to ridicule, or compels him / her to forbear from doing any lawful act, by intimidating, wrongfully restraining, wrongfully confining or injuring him / her or by using criminal force to him / her, or by holding out to him / her any threat of such intimidation, wrongful restraint, wrongful confinement, injury or the use of criminal force.


Ragging being an evil practice, is inhuman, illegal and punishable. It violates the discipline of an educational institution and adversely affects the standards of higher education. Ragging in educational institutions is banned by the Hon'ble Supreme Court of India. The Hon'ble Court has issued mandatory orders to curb the menace of ragging in educational institutions. If an applicant for admission is found to have indulged in ragging in the past or it is noticed later that he / she has indulged in ragging, his / her admission may be refused or he / she shall be expelled from the educational institution. The punishment may also be

in other forms, such as suspension from the classes for a limited period, or fine with a public apology, debarring from representation in events, withholding results, suspension or expulsion from hostel or mess, and the like. If the Head of the Institution is not satisfied with these arrangements for action, a First Information Report (FIR) can be filed without exception by the institutional authorities with the local police. The discretionary power vests solely with the University Authorities.

We at RGNUL are committed to removing ragging in all forms. In compliance with the guidelines laid down by the Hon'ble Apex Court of the country, RGNUL has constituted an Anti-Ragging Committee. Anti-Ragging Committee comprises four faculty members nominated by the Vice-Chancellor.

The Anti-Ragging Committee of the University shall assist to observe the recommendations / directions issued by the Hon'ble Supreme Court without exception, and if it is observed that there is any deviation, the Committee shall inform the University authorities.

- According to the directions of the Hon'ble Supreme Court of India in <u>University of Kerala</u> v. <u>Council of Principals' of Colleges in Kerala</u>, (in SLP no, 24295 of 2006 dated 16,05,2007) ragging within or outside any educational institution is strictly prohibited.
- 'Ragging' means any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or indisciplined activities by any student or students which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
- The University Grants Commission (UGC), New Delhi has also taken a stern view of the problem of ragging and has also issued the necessary guidelines to curb the menace of ragging.

According to the Hon'ble Supreme Court, the following recommendations need immediate implementation:

- The punishment to be meted out has to be exemplary and justifiably harsh to act as a deterrent against recurrence of such incidents;
- Every single incident of ragging where the victim or his parent/guardian or the Head of institution is not satisfied
 with the institutional arrangement for action, a First Information Report (FIR) must be filed without exception by
 the institutional authorities with the local police authorities;
- Courts should make an effort to ensure that cases involving ragging are taken upon priority basis to send the
 correct message that ragging is not only to be discouraged but is also to be dealt with sternness;
- The court has directed the exploration of possibility of introducing in the educational curriculum, a subject relating to ragging;
- In the prospectus to be issued for admission by educational institutions, it shall be clearly stipulated that in case
 the applicant for admission is found to have indulged in ragging in the past or if it is noticed later that he has
 indulged in ragging, admission may be refused or he shall be expelled from the educational institution;
- The Central Government and the State Governments shall launch a programme giving wide publicity to the menace of ragging and the consequences which follow in case any student is detected to have been involved in ragging;
- Role of the concerned institution shall also be open to scrutiny for the purpose of finding out whether they have taken effective steps for preventing
 ragging and in case of their failure, action can be taken against them, too;
- Anti-Ragging Committees and squads shall forthwith be formed by the institutions to see that the Committees' recommendations are observed without exception and if it is noticed that there is any deviation, the same shall forthwith be brought to the notice of this Court; and
- The Committee constituted pursuant to the order of this Court shall continue to monitor the functioning of the Anti-Ragging Committees and the squads to be formed. They shall also monitor the implementation of the recommendations to which reference has been made above.

Acts Amounting to Ragging Could be:

- * Teasing, Embarrassing and Humiliating;
- Assaulting or Using Criminal Force or Criminal Intimidation;
- Wrongfully Restraining or Confining or Causing Hurt;





- Causing Grievous Hurt, Kidnapping or Rape or Committing Unnatural Offence; and
- Causing Death or Abetting Suicide.


