1. The candidates have to submit the entire fee as depicted in the fee document attached herewith. RGNUL, Punjab will not be responsible for any fee transfer from any other NLU. The mess fee shall be deposited upon admission.
2. The candidates shortlisted for admission to the Under Graduate Degree Programme under various categories are required to deposit the prescribed fee on or before **23rd June 2026**.
3. The candidates shortlisted for a seat reserved under a category should submit their latest **category certificates** to avail the seat at the time of admission.
4. Please note that no individual emails to the short listed candidates will be forwarded.
5. The admission offered to the shortlisted candidates shall remain **purely provisional** and will be subject to the verification and validation of all requisite documents, eligibility conditions, and credentials by the University.
6. The candidates are required to deposit the **entire fee amount themselves**. No fee transfer, adjustment, or migration of any amount from any other National Law University shall be permitted under any circumstances.
7. Failure to deposit the fee within the stipulated timeline may result in the cancellation of the provisional admission offer.

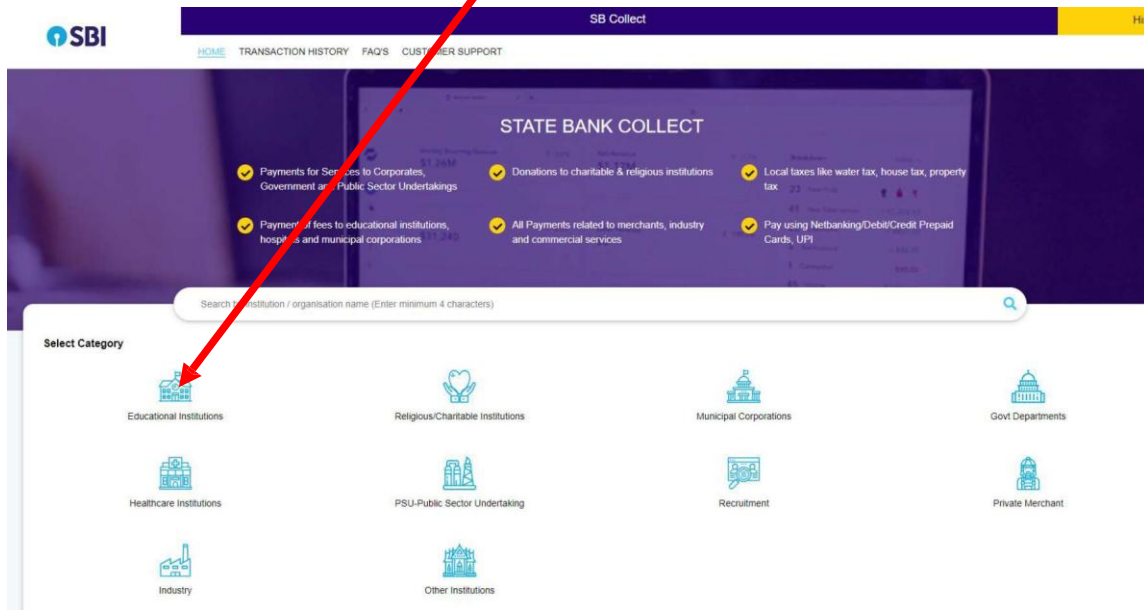

Procedure for Depositing the Fee Online

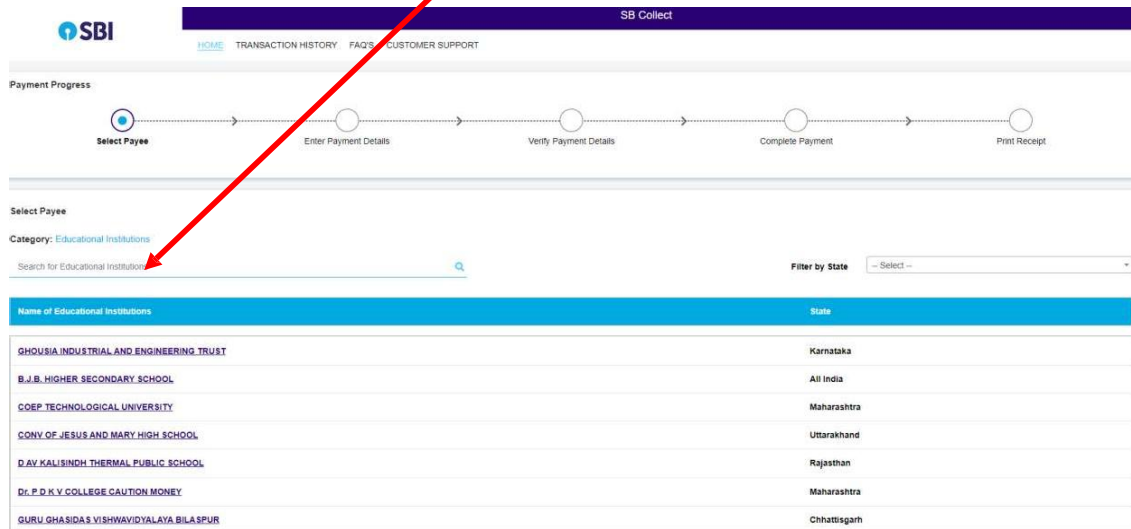
After clicking the link <https://www.onlinesbi.sbi/sbcollect/icollecthome.htm> you get the SBI Collect Portal as shown in Step 1.
