#### **RGNUL Sports and Entertainment Law Mediation Competition (SEMC)**

Launched in 2019, the RGNUL Sports and Entertainment Law Mediation Competition (SEMC) is one of India's premier ADR competitions, specifically focused on mediation within the realm of sports and entertainment law. The event attracts top ADR enthusiasts from across the country, offering them a unique platform to showcase their mediation skills in this niche area. SEMC has earned recognition for being one of the few competitions of its kind, making it a standout in the ADR landscape. With its rigorous problem statements and expert panels of judges, SEMC provides participants with invaluable insights into real-world disputes, honing their abilities to resolve complex legal issues.

### **RGNU National Negotiation Competition**

With three successful editions in collaboration with Shardul Amarchand Mangaldas (SAM), one of India's leading law firms, this competition provides an exceptional opportunity for participants to develop negotiation skills. Each year, the event witnesses participation from leading law schools across India, fostering intense competition and delivering an unmatched platform for learning and growth in negotiation strategy.

### **Surana & Surana & RGNUL International Arbitral Award Writing Competition**
