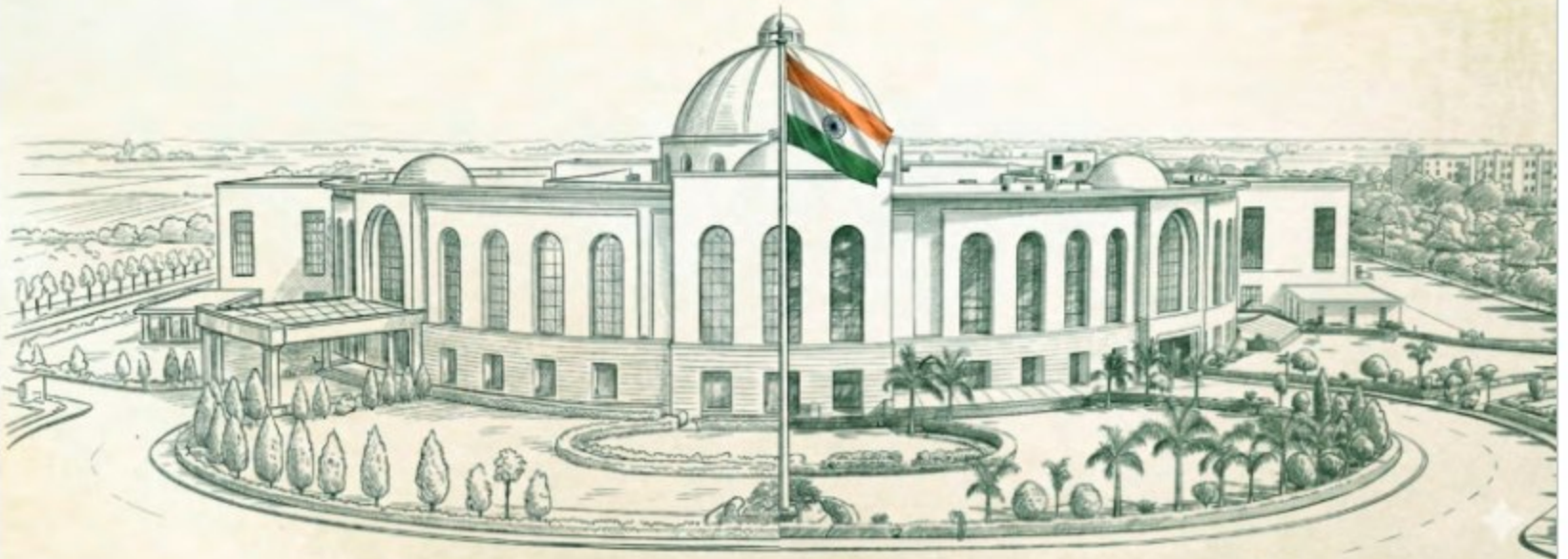

# ABOUT RGNUL

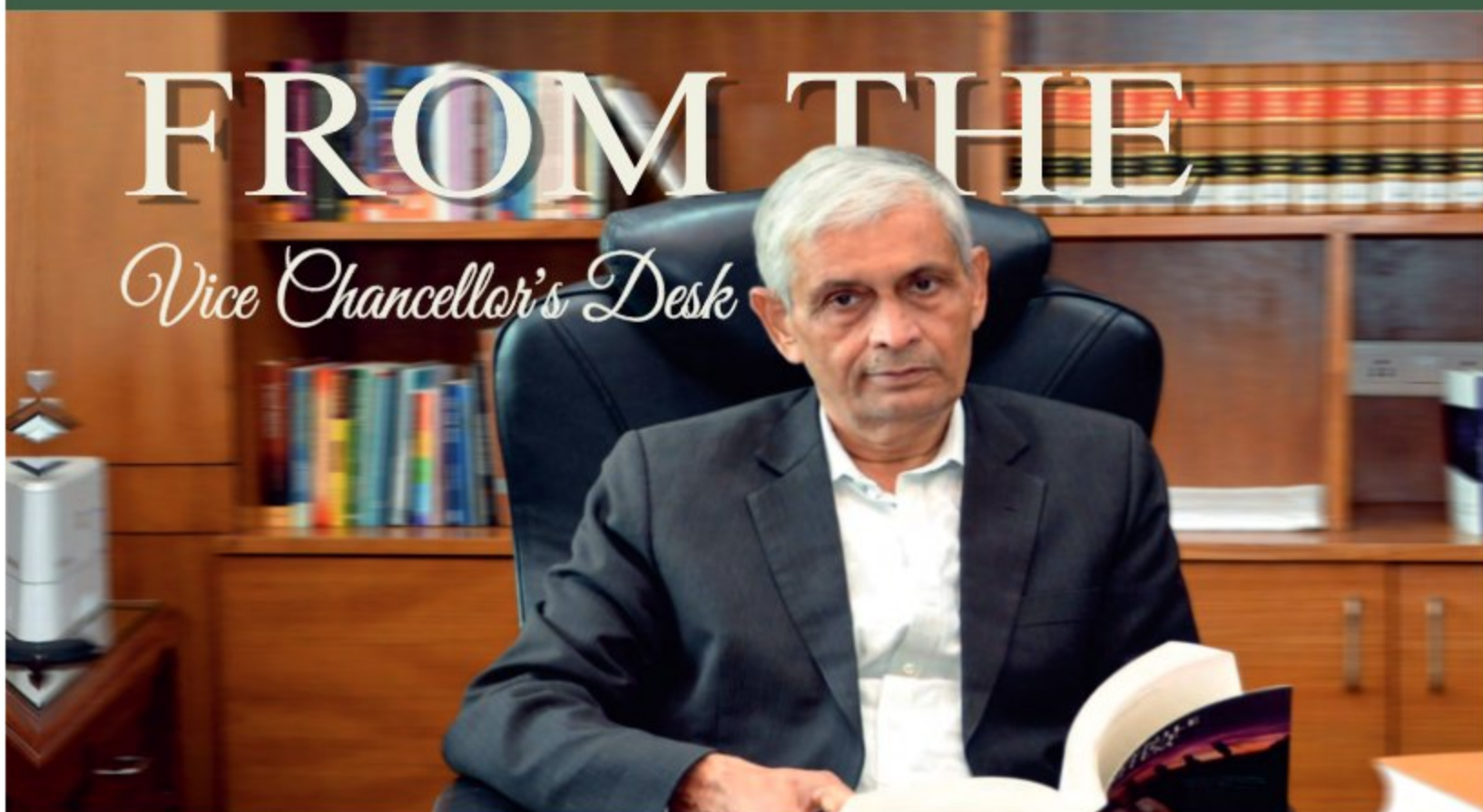


The Rajiv Gandhi National University of Law (RGNUL), Punjab, was established by the State Legislature of Punjab by passing the Rajiv Gandhi National University of Law, Punjab Act, 2006 (Punjab Act No. 12 of 2006). The Act incorporated a University of Law of national stature in Punjab, to fulfil the need for a Centre of Excellence in legal education in the modern era of globalization and liberalization. The University got registered with the University Grants Commission (UGC), New Delhi under Section 2(f) of the University Grants Commission Act, 1956 and has been declared fit to

obtain a grant from the UGC under Section 12-B of the UGC Act, 1956. The University was accredited with an 'A' Grade by the National Assessment and Accreditation Council (NAAC) in 2015. RGNUL, Punjab was granted autonomy under the UGC Regulations, Clause 5 Dimensions of Autonomy for Category-II Universities in April 2018. The Ministry of Human Resource Development, Government of India, ranked RGNUL as the first amongst the cleanest Higher Educational Institutions, Swachh Campus (2019) in the category of Government Residential Universities.

Rajiv Gandhi National University of Law, Punjab is a residential university operating at its campus in Sidhuwal, Patiala-Bhadson Road, Patiala (Appx: 47.30 acres). All students live in hostels (separately made blocks of hostels for boys and girls). The University provides all required services to students on campus, including a health centre, a bank, a post office, a canteen and cafeteria, a stationery and book shop, a laundry service, a gym, and other sports facilities. The Guest House, VIP Guest House, twenty-eight faculty houses, thirty-two non-teaching residences, and sixteen houses for class IV employees are all fully occupied. The entire campus is connected by well-kept roadways and is surrounded by lush greenery. More than 66% area of the campus is under green cover.

# ACADEMIC INITIATIVES

## 1. Law Practicum Series

The Law Practicum Series was introduced to ensure that students are imparted with proper technical and industry-specific knowledge. Through intensive teaching and the use of practical, real-world examples, it aims to enhance understanding and bridge the gap between substantive legal knowledge and the challenges faced in practice. The practicum adopts a pedagogy wherein industry experts and legal practitioners are invited to deliver lectures on specialised and advanced subjects, enabling students to engage directly with real-world legal issues.

## 2. RGNUL Student Academic Assistance and Support Policy

RGNUL Student Academic Assistance and Support Policy (RSAASP) offers an opportunity for the academic growth of the student. The aim of RSAASP is to enhance the efficacy of the learning environment for students from diverse educational backgrounds. RSAASP is assisted by committees comprising faculty and student assistants. RSAASP encompasses a broad array of academic activities- access to support for resolving academic queries, acquaintance with the contours and requirements of the course, extra-tutorial assistance, comprehension of Project Work, aid for non-English medium/language related issues, guidance for research and practical exposure/training throughout the five-year B.A.LL.B. (Hons.) Programme. The Policy reflects the collaborative spirit at RGNUL as students and faculty coordinate for the management of activities. RSAASP ensures productive assistance to new students, facilitates initial transition to University studies, encourages inter-batch association and extends another avenue of learning in integration with the classroom environment.

## 3. Research Outcome Dissemination Series (RODS)

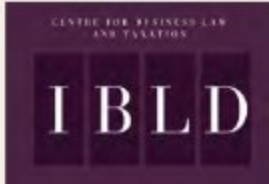
The Research Outcome Dissemination Series (RODS) is one of the initiatives by RGNUL to ensure high-quality research. RODS was introduced for the enhancement, dissemination, and amplification of quality research and the application of innovative findings with respect to real-world situations. It takes into consideration the interdisciplinary and quality legal and factual understanding of the situations via collaborations and partnerships with different organizations, including private and public organizations such as government departments, academic institutions and international and national think tanks, and other research institutions. The most striking feature of RODS is that it includes participation from all levels, including agencies, research scholars, students, and other professionals. Each session spans half an hour, where the initial half is devoted to understanding the research questions and the rest half-open to the discussion.

## 4. Interdisciplinary Teaching

Interdisciplinary teaching has been introduced to prevent stagnation of knowledge by encouraging the convergence of concepts from the social sciences with various fields of law. Different methods of teaching are being experimented with and implemented to strengthen this integrated approach. This enables students to develop a more practical understanding of the field while also helping them assess their areas of expertise and interest.

# Journals And Periodicals

## RGNUL BOOK SERIES ON CORPORATE LAW AND CORPORATE AFFAIRS (RBS)

The acclaimed RGNUL Book Series on Corporate Law & Corporate Affairs (RBS) is a bi-annual, student run, peer reviewed book series established in the year 2016. It falls under the aegis of the Centre for Business Laws and Taxation (CBLT). The book series aims to focus on contemporaneous legal issues related to General Corporate Governance, Banking, Financial Services and Insurance, Consumer Products and Retail, Sports, Dispute Resolution, Communications (Telecom & Broadcasting), Competition Law, Mergers & Acquisition, Taxation, etc. with contributions from practitioners, legal academicians, professionals, undergraduate and postgraduate students, etc. Since its inception, RBS has successfully published four volumes titled 'International Taxation', 'Corporate Regulations', 'Corporate Governance', including their latest volume on 'Mergers & Acquisitions' (2021). Their upcoming (fifth) volume is centred around 'Competition Law' and is under review currently.



## RGNUL STUDENT RESEARCH REVIEW (RSRR)

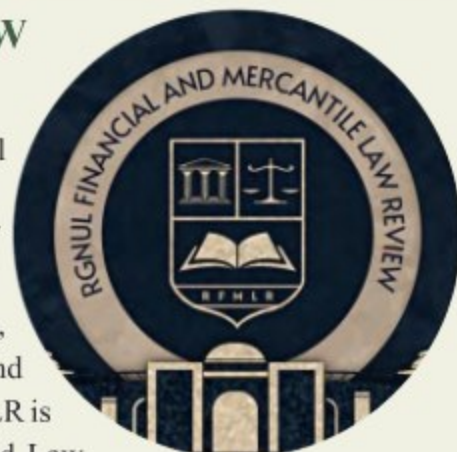
RGNUL Student Research Review (formerly known as the RGNUL Student Law Review) was constituted and registered in the year 2013. RSRR is a bi-annual, student run, and blind peer reviewed, flagship law journal based at Rajiv Gandhi National University of Law, Punjab. The RSRR Journal strives to publish comprehensive treatments of subjects ("articles"), written by law students and industry experts on contemporary issues, from different areas of law. RSRR aims to stimulate discussion on contemporary and less explored issues through the themes chosen for the Journal as well as the monthly blogs. It seeks to create a platform for academicians in the field and stakeholders of the industry to express their views and opinions alike and share insights to their experiences. As a research review, RSRR not only attempts to bring about critical analysis of laws but also of policies, rules or guidelines involved in the chosen issue. RSRR invites and encourages authors to put forth constructive solutions to bridge the gap between theory and practicality. In the short period since its constitution, RSRR has been ranked among the top 35 constitutional law blogs by Feedspot and has featured as one of the 13 Indian Law Journals in the 2019 list of W&L Law Journal Rankings.



# Journals And Periodicals

## RGNUL FINANCIAL AND MERCANTILE LAW REVIEW (RFMLR)

RFMLR is a student-run, bi-annual, double-blind peerreviewed journal published by the Rajiv Gandhi National University of Law, Punjab established in the year 2014. It is one of the flagship publications of RGNUL and is run and managed by a student Editorial Board. The journal gives an opportunity to the legal academia, legal professionals, and law students to contribute cuttingedge, doctrinal, theoretical, and empirical research in the field of business and commercial laws. RFMLR is indexed on SCC Online and has been ranked the 6th most accessed Law Review in India on the platform. The Editorial Board has published seven volumes comprising two bi-annual issues each, and Six Special Issues till date. Further, the Board also published Volume XI Issue I of the Journal recently, and is currently in the process of publishing Volume XII Issue I. Further, the Editorial Board also operates the RFMLR Blog on its website. The Editorial Board also publishes a monthly Newsletter (Au Courant) that covers the latest happenings in different sectors of commercial laws, in addition to interviewing many noted practitioners and academics in order to understand their views on the pressing issues of the day. Au Courant is the flagship newsletter of the RGNUL. Financial and Mercantile Law Review (RFMLR), published on a monthly basis.



## REVIEW OF ALTERNATIVE DISPUTE RESOLUTION (RADR)

Inaugurated in February 2025, the Review of Alternative Dispute Resolution (RADR) is an annual, student-run, double-blind and peer-reviewed publication series that strives to provide a stage for discussions related to innovative aspects of dispute resolution and their intersection with upcoming complex areas of law such as Competition Law, Family Law, Intellectual Property Law, Medical Law, Insolvency Law, Media Law, etc. RADR, under the aegis of Centre for Alternative Dispute Resolution (CADR), has received contributions from undergraduate students, practitioners, academicians, etc. It offers a meaningful opportunity to interested contributors to bring their research efforts into fruition and analytically explore contemporary developments in different segments of law with their relation to dispute resolution.



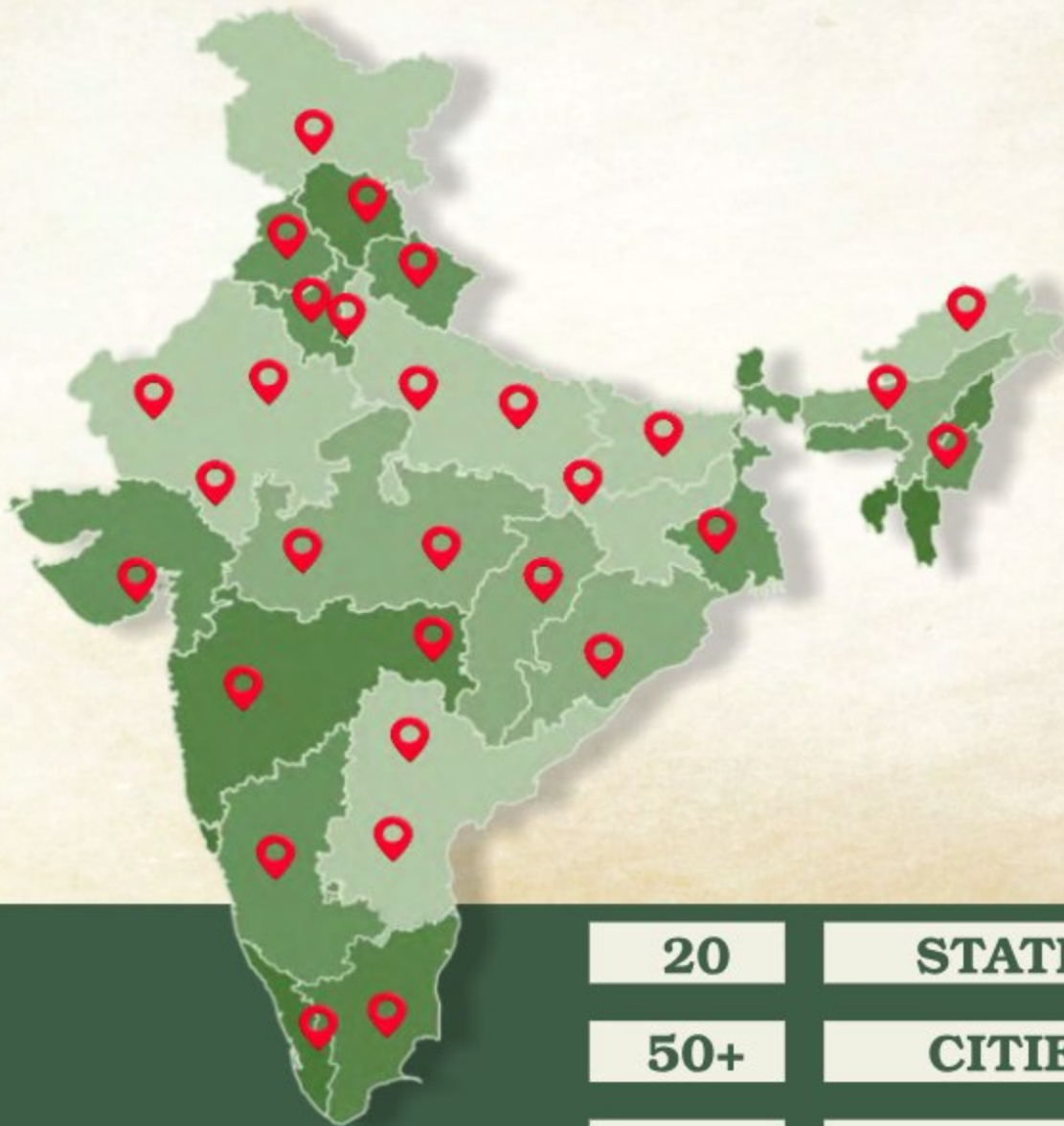
# INTRODUCING

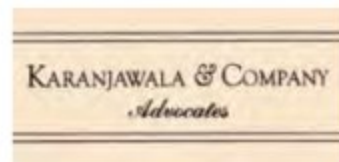

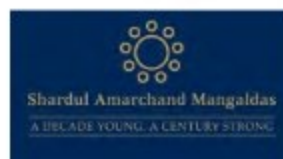

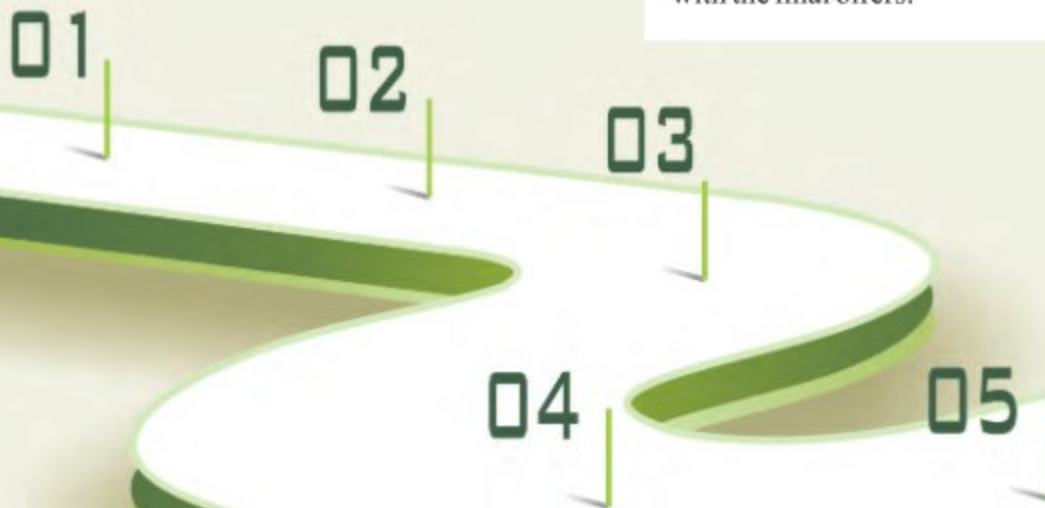
## Note :

1. Recruiters are encouraged to visit the RGNUL campus for the placement process. However, in case a recruiter is unable to visit, any session including the Pre-Placement Talks, Pre-Interview Screening Process or Final Interviews can be conducted through videoconferencing or any other suitable method.
2. Recruiters are requested to communicate with the Placement Cell through the contact details provided at the end of the Brochure. The Cell will assist the recruiter with the recruitment process as well as the travel and accommodation requirements.
3. The Placement Cell is the sole body authorised to communicate with the recruiters and any attempt by the applicant to engage in personal communication is barred. The decision of the Placement Cell regarding the selection of candidates shall be final and binding on all parties.

# RECRUITMENT *Process*

The Placement Cell for the Batch of 2027 is the student body officially designated with the responsibility of facilitating the procedure of recruitment for the graduating Batch of 2027 and providing all necessary information to a recruiter. Therefore, in order to ensure that a robust system is in place, without compromising on the availability and preferences of the Recruiter, the following steps have been undertaken by the Placement Cell to streamline the recruitment process for the recruiter as well as the students:

- 01** Initial Communication with the Recruiter- the Placement Cell shall send invitations to recruiters along with the placement brochure and relevant information. Alternatively, an organisation may send a description of potential career options and requirements to [Placementcellrecords@rgnul.ac.in](mailto:Placementcellrecords@rgnul.ac.in)
- 02** Pre-Placement Talks to ensure a fair & transparent process, and to make the candidates aware of the recruiter's vision, career prospects, compensation package, employer expectations and work culture. We encourage Pre-Placement Talks by the recruiter with the interested candidates, however, the same is subject to the discretion of the recruiter.
- 03** Pre-Interview Screening Process- If the recruiter deems it appropriate, a Pre-Interview Screening Process may be conducted prior to the final interview. The process may include virtual interviews, group discussions, written questionnaires or any other process that the recruiter considers necessary.
- 04** Final Interview- Subsequently, the recruiter shall communicate a list of candidates to the Placement Cell who are to be interviewed for the position offered, along with a discretionary waitlist of potential candidates.
- 05** Intimation of Offers- The recruiter shall intimate offer(s) made to the selected candidates solely through the Placement Cell. If the recruiter deems it appropriate, a waitlist may be disclosed along with the final offers.



# RECRUITMENT PROCESS

## TRAVEL TO CAMPUS

The Placement Cell can facilitate travel by providing precise information upon request. The Rajiv Gandhi National University of Law, Punjab shifted to its permanent campus in May 2013, situated in Sidhuwal on Bhadson Road in Patiala, Punjab.
