### 17. Multidisciplinary / interdisciplinary

At the Rajiv Gandhi National University of Law (RGNUL), interdisciplinary teaching is actively promoted through innovative courses, programs, and research initiatives that bridge the gap between different academic disciplines. By combining expertise from the Faculty of Law and Social Sciences, RGNUL creates a dynamic and engaging learning experience for its students. 1) Sharing lectures: For example, courses like Jurisprudence, which explore various philosophies of law concerning the state and its institutions, often overlap with Political Philosophy. Faculty members from the Department of Political Science are invited to contribute to topics in Jurisprudence, such as the Right to Information, enabling students to gain perspectives that extend beyond traditional legal boundaries. Conversely, Law faculty share their expertise in social science subjects like Center-State Relations, Fundamental Rights, and Legal Culture, enriching the curriculum with diverse viewpoints. 2) Holding joint conferences, seminars and lecture series: Interdisciplinary collaboration at RGNUL extends beyond the classroom through joint conferences, seminars, and lecture series. Faculty members from both Law and Social Sciences engage in cross-disciplinary conferences, seminars etc to stimulate in-depth debates on shared themes such as Justice and Equality. This further enriches the discourse around the topics and promotes exchange of iseas across the disciplines. Additionally, parliamentary debates are frequently organised, where faculty from Law and Political Science offer insights that enhance students' understanding of complex legal and political issues 3) Innovative courses: RGNUL has introduced diverse credit courses that amalgamtes the insights from Law and Social sciences. For insatnce, the recently launched course like Human rights and Justice blends insights from Political Science, History and Sociology to address the issues pertaining to justice and rights in the contemporary world. 4) Inter-disciplinary FDP: To promote, inter disciplinary education and ensure that the faculty is well versed to deliver the inter-disciplinary lectures, FDPs are organised frequently. These programs enable faculty from Law and Social Sciences to share the latest developments in their respective fields and explore their applications in teaching to create an enriching environment for students. 5) Inter disciplinary Projects: RGNUL encourages students to apply social science methodologies to solve legal issues through interdisciplinary

projects. Annual project assignments prompt students to explore intersections between law and social sciences, addressing complex societal problems through innovative approaches.

#### 18. Academic bank of credits (ABC):

As envisioned by the government of India, through the New Education Policy (NEP) 2020, RGNUL has already registered for the Academic Bank of Credits, on the Government Portal and the data of the students has already been uploaded on the portal. The students, asper the requirement of the ABC policy, have been instructed to create their account with the Academic Bank of Credit of India, so that they are able to avail complete benefit of the CBCS scheme implemented for all degree programs at the university. The course scheme at RGNUL provides for the students to choose amongst the various credit courses introduced under the aegis of the MOOCs scheme, through the SWAYAM portal. The credits earned by the students shall be uploaded by the university at their respective portals. Thus the students can take benefit of the Bank of Credits, while opting for various avenues after completing their graduation degree at RGNUL.

#### 19. Skill development:

Skill Development lies at the heart of RGNUL where the academic course of B.A.LL.B (Hons.) and LL.M is designed to enhance the skill set rather than increasing rote learning. Besides, the focus remains more on empirical learning by facilitating field visits for students so that they can learn by experiencing the real problems. Additional emphasis is put on the professional training of the students by virtue of facilitating the internships, moot competitions and annual debate competitions like Agahi. 1) Course on Legal Methodology: It has been designed in a way that helps students to understand the research methods used in law and social sciences and enhance their research potential. 2) Mediation, Arbitration and Negotiation competitions: In a bid to develop the lawyering skills amoing students, RGNUL promotes and organises various National and International mediation, negotiation and arbitration competitions that promotes alternative dispute resolution mechanism skills. To facilitate the same, RGNUL has established P.C Markanda Chair to give an ode to the father of arbitration. The mediation competition on Sports and Entertainment law garnererd wide audience from across the country. 3) Moot Competitions: To enhance the argumentation skills of the students, RGNUL hosts a range of Intra and Inter Moot competitions. Having the best moot court infrastructure in the country, it has been actively enagged in organising prestigious moot competitions. The Surana and Surana Moot competition is one of the prestigious moot competitions that RGNUL hosts every year. These competitions have helped the students across the country to ace their mooting skills, drafting skills and has helped them develop courtroom etiquettes. 4) Research centres: RGNUL has many reserach centres which help the students to develop the legal research skills. These research centres engage students in rigorous reasearch and encourage publications with reagrd to their activities. Among all the research

centres, CADR (Centre for Alternative Dispute Resolution) is the pioneer in enaging the cross-cutting research. these research centres develop and refine the legal reasoning of the students by engaging them in various activities. 5) Pro bono club:

### 20. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

The RGNUL offers Five Years UG Course and One Year PG Course. The students in their course curriculum are offered study of Indian philosophical systems, thought and writings. The courses are interdisciplinary and have enough space to accommodate Eastern and Western thinkers. The students are taught Kautilya, B. R. Ambedkar, Swami Vivekanand, Mahatma Gandhi, Baby Kamble, Nyaya and Mimamsa Philosophy. Being professional law course curriculum include of study of Indian Laws and the Thought and Philosophy behind it.

#### 21. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

A. The Course Curriculum for UG and PG Programmes at RGNUL includes very precise and relevant learning outcomes and Course Objectives. Entire curriculum schedule (Number of classes, number of credits, number of hours for project / project presentation, exam) is managed to offer both time and resources to fulfil learning outcomes and course objectives. B. The Rajiv Gandhi National University of Law (RGNUL), Punjab has initiated the Research Outcome Dissemination Series (RODS) to promote quality research. Dissemination of research findings is an integral part of the research process. The distribution of new knowledge gained through research an prompt application of innovative findings to real world situations. The utilization of research findings is of great interest to practitioners and policy makers. In order to enhance the visibility of research findings and to effectuate the implementation of new research, dissemination becomes imperative. RODS envisages quality legal and interdisciplinary research. #### 22. Distance education/online education:

Directorate of Distance Education (DODE) aims at imparting legal knowledge amongst learners from all over the country. DODE has been established specifically to put forward a functional response to universalize of legal profession. Degrees and Diplomas in fields like Consumer Protection Laws and Advocacy, Law and Medicine, Environmental Law and International Humanitarian Law, are proposed to be undertaken by the DODE. DODE shall operate through the most contemporary modes of teaching and learning. The students enrolled for a particular degree or diploma shall be provided with a detailed 'Study Material' related to the contents and this study material shall entail research based exploration of the themes concerned. The teaching and the learning techniques shall be

formulated specifically taking into consideration the regional differences of the students getting enrolled from various states and nations. Special emphasizes shall be put on the pre-requisites like language, time duration and time management, postal obligations, response and assessment mechanisms, etc. On the whole the main target of the DODE shall be to impart education transcending the regional and the national boundaries. # 2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problem-solving methodologies are used for enhancing learning experiences

For enhancing learning experiences the faculty members adopt many ways, for example, lecture method, interactive method, project and field work method, computer-assisted method, experiment method etc. Teaching and learning activities are made effective by these practices. Many teachers use the conventional black-board presentation methods. Also, some teachers use power point presentations and

computer-based materials. For, they use the lectures of you-tube to make learning interesting besides the conventional oral presenting methods. Some Student centric methods are given below:

Simulation by Case Exercise Method: Procedural law teachers use simulation methods using case exercises to develop critical thinking among students. This also helps students to understand nuances of procedural laws.

Project methods: The project work stimulates student's interest in the subject and provide the student an opportunity of freedom of thought and free exchange of different views. As per the requirement of syllabi, the project work is done. For example, the Projects are done in UG and PG classes.

Interactive methods: The faculty members make learning interactive with students by motivating student participation in group discussion, role-play, subject quiz, news analysis, educational games, discussion and questions and answers on current affairs, etc.

ICT Enabled Teaching: ICT-enabled teaching includes WI-Fi-enabled classrooms, Smart Classrooms, etc. The institution adopts modern pedagogy to enhance the teaching-learning process.

# 2.5.3 - IT integration and reforms in the examination procedures and processes (continuous internal assessment and end-semester assessment) have brought in considerable improvement in examination management system of the institution

For upgrading and keeping abreast with the contemporary requirements of the examination system, RGNUL has adopted Choice Based Credit System (CBCS) since 2017 and under the scheme, each paper is allotted specific credits so as to meet the requirements of the industry and academia outside the university. Accordingly, the papers are conducted in two parts - i.e the mid-semester and the end

semester exams. The question papers are prepared with an application-based approach, so as to evaluate the student's knowledge holistically. The evaluation of the papers is also accompanied by the practical part which is conducted in the form of a Comprehensive Continuous Evaluation System (CCE), whereby the students are required to submit their project assignments on a topic allocated to them and are required to make a Power Point presentation and appear for a viva voce for the same. Each student is required to pass separately in the theory as well as the practical paper. Apart from all these, RGNUL also has tie-up with the National Academic Depository(NAD) to ensure that the graduating students can have access to the electronic copy of their degree, which can be downloaded, from anywhere in the world.

#### INFRASTRUCTURE AND LEARNING RESOURCES

#### 4.1 - Physical Facilities

4.1.1 - The institution has adequate facilities for teaching - learning. viz., classrooms, laboratories, computing equipment, etc.

The total campus is Wifi enabled with centralized UPS. RGNUL has 12 Classrooms with Projectors, smartboards, computers, and centralized air conditioners. Rooms are well-ventilated and have sufficient light(natural as well as electrical).

RGNUL has six lecture theatres (one each for six classes i.e. five years of B.A. LL.B. (Hons. and one year LL.M. course. Lecture theatres are equipped with the latest state-of-the-art podiums with touchscreens, projectors, screens, and inbuilt mike. Each lecture theatre is air-conditioned and can house 120 to 175 students at a time. In addition, RGNUL has 6AHUs.

RGNUL has four computer labs for students and faculty with Dell, Apple Desktop, and printers.

The University has established Forensic Lab to impart practical training in investigation and trials. RGNUL has a Lab for Specially abled persons.

University has an automated Library which can be accessed online and offline. RGNUL has subscribed to all important legal databases and remote access is provided to students and faculty.

To ensure online learning, RGNUL has purchased CiscoWeb Ex Solutions and has subscribed to platforms like Lexis Advanced and EBC Reader where students can access not only databases but also books and bare acts.

Professionally trained personal trainers/ coaches, for boys and girls separately, are available to guide the work out regimes of the members attending the Gym.
- 2) University has a multi purpose hall which is used for academic as well as activities like cultural activities and Yoga activities.
- 3) RGNUL has state of the art double story Auditorium which can house around 1100 students. Auditorium is used for cultural, academic and other activities. It is equpped with latest state of the Art infrastructure like digital laser sound, Y4K screen, projectors etc.
- 4) In order to enable students and faculty resident on campus to participate in games and sports, RGNUL has provided facilties for indoor and outdoor games. RGNUL has playground for cricket and other games.

### 7.1.3 - Describe the facilities in the Institution for the management of the following types of degradable and non-degradable waste (within 100 - 200 words)

Sewage Treatment plant has been constructed for 100KLD and extendable up to 200 KLD. Accordingly, STP of200 KLD capacity has been made functional. RGNUL is managing its present 105 KLD treated waste water being received from the Sewage Treatment plant for irrigation of green belts.

There were about 40 lac litre of water in this area due to abandoned brick kilns & fish ponds. The water was recharged to ground. Before recharging the groundwater, the sand filter was prepared the filtered water was recharged to ground.

Campus is successfully managing the rain water through 15 (fifteen) properly designed rainwater harvesting structure. RWH structures are well managed& are working very well. These structures are cleaned very year before the onset of rainy season. RGNUL has been successful in recharging the precious groundwater to the tune of approximate 45428 Cubic metre per year through these RWH structures.

Solid Waste management (Vermiculture) has been developed on the campus by separating the degradable non-degradable materials. Degradable material is processed under Vermiculture system and the vermicompost produced is being used in gardens /flower beds etc. The non-degradable materials is sent for recycling.
