IMPORTANT INSTRUCTIONS

1. **Admission against the vacancies declared shall be made strictly on the basis of CLAT Merit only.**
2. Candidates must ensure that **all relevant certificates and supporting documents are uploaded** while submitting the application form.
3. It shall be **mandatory for every applicant to pay the prescribed application fee of Rs 1,180/-** at the time of submission of the online application form. Fee shall be paid through the link: https://rgnul.lsacademia.in/lsa_rgnul/eventPortal/loginFrom.jsp
4. Candidates applying for admission to the **LL.M. Programme** must upload the **latest available marksheet and/or documentary proof of eligibility pertaining to their Undergraduate Degree Programme** and category applying under (if applicable).
5. Candidates claiming reservation or admission under any special category shall upload the **latest valid category certificate(s)** issued by the competent authority.
6. In case any required document is not available at the time of submission of the application, the candidate shall upload a duly signed **Undertaking**, clearly indicating the reason for non-availability and the expected date by which the document shall be submitted.
7. Candidates are advised to carefully verify all particulars furnished in the application form before final submission. Incomplete applications or applications without the prescribed fee or applications supported by wrong/irrelevant documents shall not be considered.
8. The University reserves the right to verify the authenticity of all documents submitted by the candidates at any stage of the admission process.
9. Mere submission of the application form shall not confer any right to admission. Admission shall be subject to verification of eligibility conditions, merit position, availability of seats, and fulfillment of all requirements prescribed by the University.
10. The decision of the University regarding admissions and interpretation of eligibility conditions shall be final and binding upon all applicants.
11. These vacancies are inclusive of the increased seat intake for the LL.M. programme at RGNUL Pb from Academic Session 2026-27 onwards.
