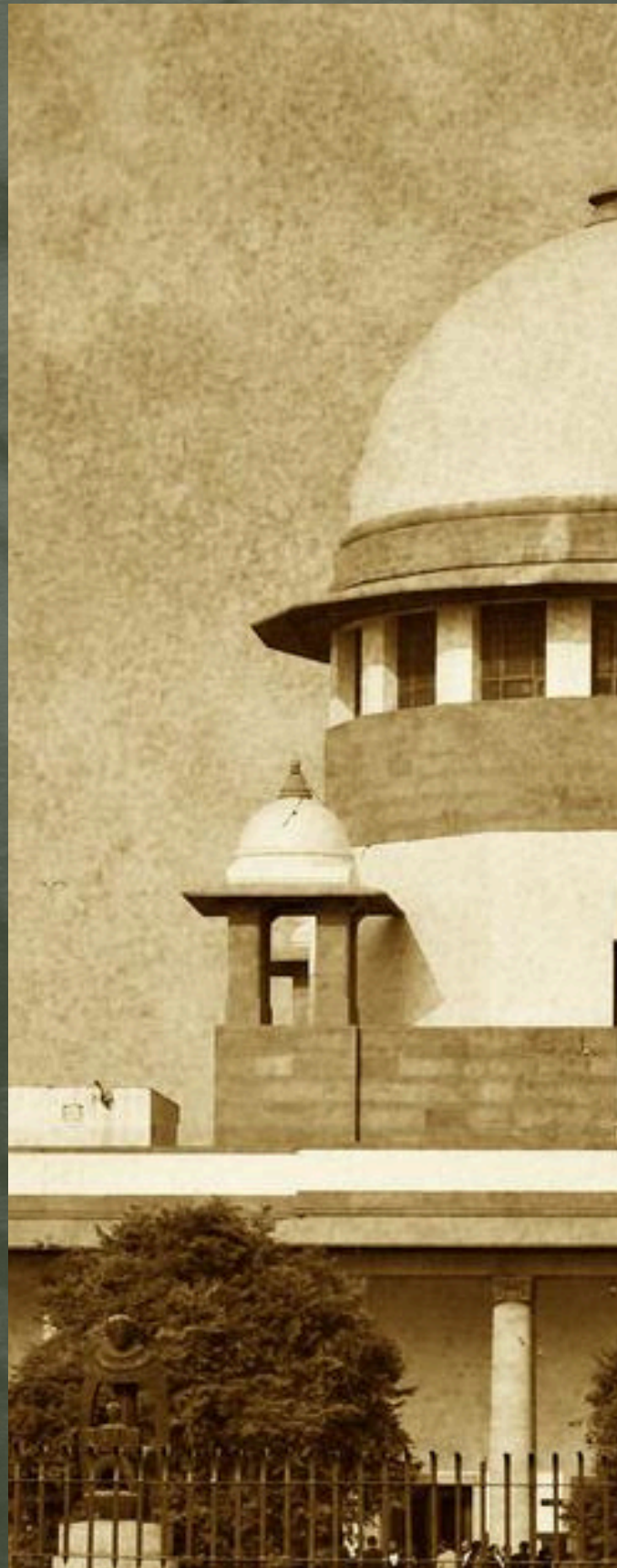

Full Paper: 4000-6000 words, in Microsoft Word format (.doc/.docx).

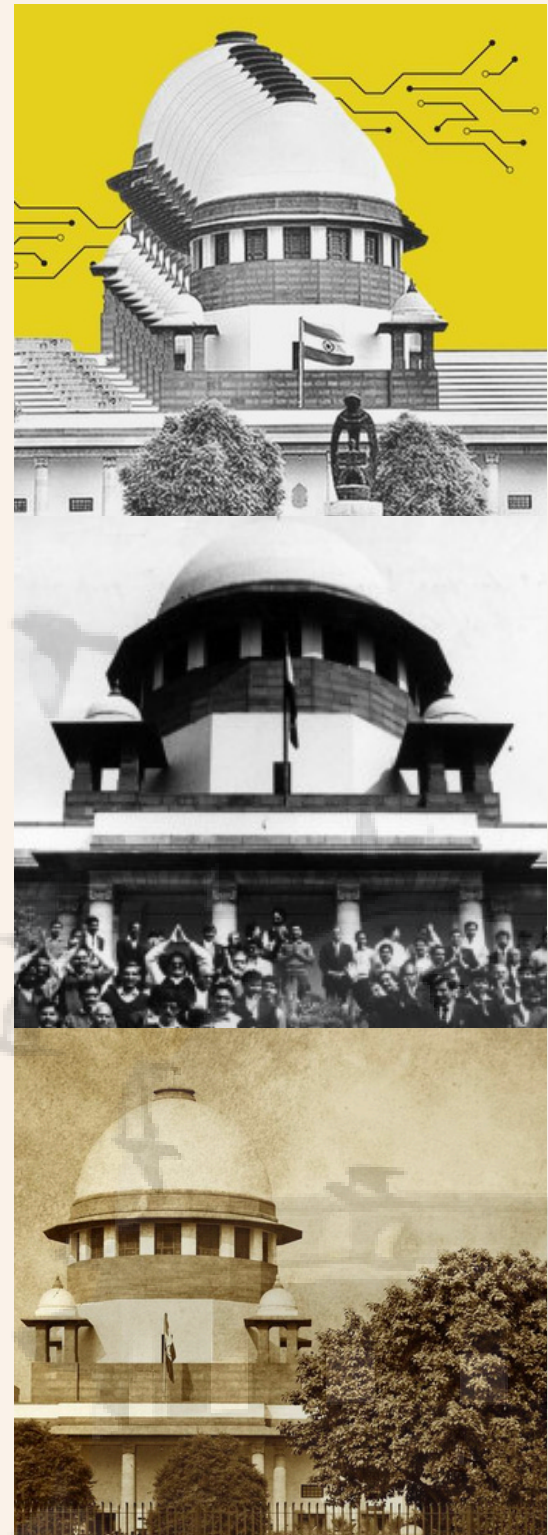
Citation Style: Harvard Bluebook 21st Edition.
