ABOUT THE PRACTICUM COURSE

This course focusses on Dispute Resolution in Practice within the specialization of Insurance and Arbitration. The course will take the students through the lifecycle of involvement of a practicing lawyer in insurance related Dispute Resolution i.e., from legal advisory to litigation covering the various stages in between such as contract drafting, contract negotiation, risk allocation, risk mitigation and arbitration. It will have a strong emphasis on understanding the business and commercial aspects to assist clients in a more experienced and practical manner. Often, we ignore the importance of pre-dispute advisory or a well drafted contract until a dispute arises. That is when we regret not having included a clause or having agreed to a clause which we should have avoided.

These clauses and requirements vary largely from industry to industry. It involves knowledge of the mechanisms available under the contract law and an understanding of the business models of each sector. To help a business achieve its vision and goals, the role and importance of a good lawyer cannot be emphasised upon enough. This course would focus on understanding the nuances of business, developing insight into commercial law and creating a foresight to avoid disputes where possible.

- Aspects of an insurance contract
- Interplay of principles, risk allocation provisions, anti-assignment clause, review of insurance policy,
- Assessment of proposed insurance requirements in commercial contracts,
- Methods of amicable dispute settlement procedure,
- Issue of choice of law v. jurisdiction,
- Arbitration or mediation in commercial insurance claims,
- Role of consumer courts in insurance disputes and
- Appeal to supreme court in insurance matters.
