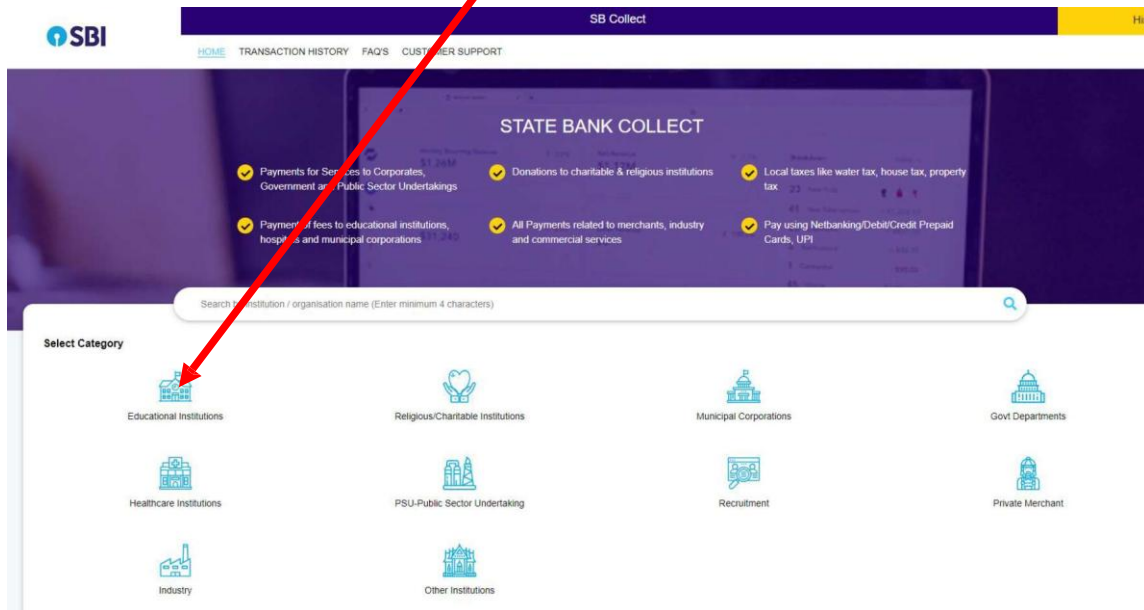

## Procedure for Depositing the Fee Online

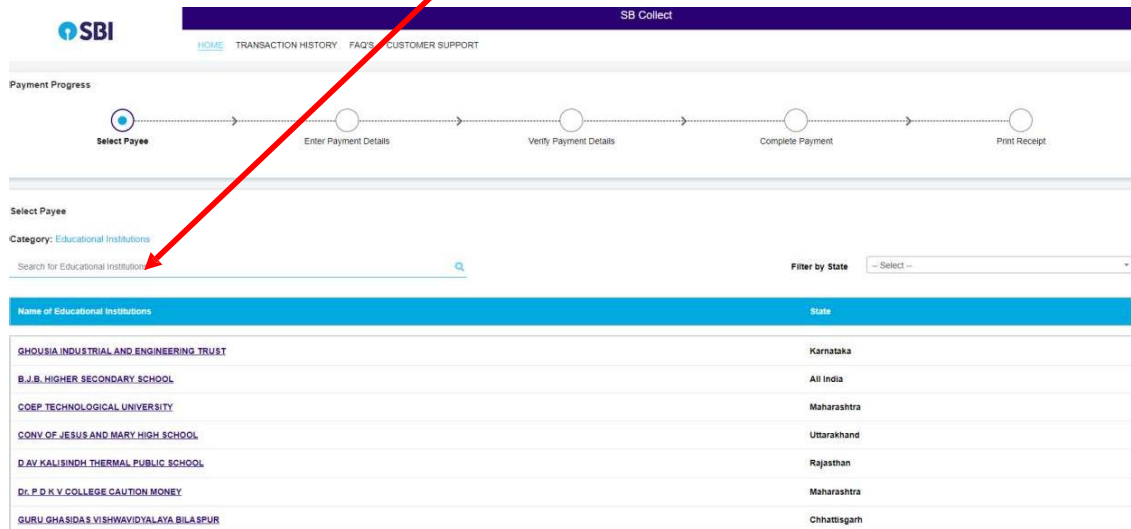
After clicking the link <https://www.onlinesbi.sbi/sbcollect/icollecthome.htm> you get the SBI Collect Portal as shown in Step 1.
