### [AMENDED] RULES OF THE COMPETITION

#### **GENERAL GUIDELINES**

- The Competition shall be open to the students who are pursuing their BA LLB/LLM/PhD/MPhil or any other Undergraduate or Masters courses (other than Law) in any university across the World.
- 2. Individual participation as well as participation in a team of two i.e. co-authorship is allowed.
- 3. The format of the Award shall be in the following chronological order. Please peruse the Arbitral Award Draft for reference.
  - a. Cover Page: The cover page must include the name of the competition, name of the parties and the name of the student author(s).
  - b. Statement of Facts
  - c. Issues in Dispute
  - d. Arguments from the Claimant and the Respondent
  - e. Decision and Award
- 4. The Award must be submitted in both Microsoft Word and PDF format.
- The Entry must be typewritten. Font: Times New Roman, font size 12, line spacing
  1.5 and justified alignment; proper page numbering should be inserted.
- 6. Margins: 1 inch on all sides.
- 7. The manuscript should be accompanied with a covering letter specifying the author's name, designation, institute, contact number and e-mail for future reference.
- 8. The Bluebook, A Uniform System of Citation (**20th Ed**.) is to be followed. All footnotes must be in Times New Roman, size 10, single-spacing and justified.
- 9. There is no registration fee for the competition but the participants are required to fill the <u>registration form (https://forms.gle/JZrwAM2HvE2R1TQ36</u>).





10. If any Student of the RGNUL is positioned amongst the top three, he/she will not be eligible for the top three prizes but will be felicitated in recognition of his/her performance with a special prize by the Surana and Surana International Attorneys, Chennai.
