### **MANDATORY INSTRUCTIONS FOR THE CANDIDATE**

**The Candidate is required to abide by the following guidelines, failure of which shall result in the application being summarily rejected at the threshold:**

1. The applicant candidate must register on the official website of the CAN Foundation – [www.canfoundation.in](http://www.canfoundation.in) through the link provided on the PROJECT EKLAVYA Page. The registration must be done on the website by necessarily furnishing all the particulars required under the information in relation to all the heads. **Applications of unregistered candidates shall not be entertained.** The Candidate must also refer to the FAQs on the aforementioned website in case of queries.
2. The Candidate must fill out the information in the Form (Pg. 5-17) digitally in a typed format.
3. **Important Note:** If in case the candidate is under the care of a guardian, rather than their parents or mother, it is mandatory to provide the guardian's details (information and required documents) alongside the parents' details in all sections of the application form wherever necessary. Additionally, the candidate must explicitly state in the application form that the individual mentioned as the guardian is indeed their legal guardian and responsible for their care. Failure to accurately disclose this information may result in the application being deemed incomplete.
4. The Candidate must ensure that every page of the Application Form along with all the relevant Annexures is duly signed by the Candidate and both the Parents/Guardians. In the case of a single parent/guardian, then only the signature of the single parent/guardian is required.
5. The Candidate must take due care in filling out the Checklist and must specify the reasons for not attaching any of the documents listed as "non-essential".
6. The results of the student must be submitted in percentage CGPA format. As each university has its own conversion mechanism, if the result is not in percentage format, then the student must take note of the following points:
  - (i) The candidate is required to submit the conversion mechanism, which is issued by the university's examination department.

- (ii) The candidate is required to convert his marks from CGPA to percentage as per the calculation method adopted by the University and mention such calculated percentage in this Form.
7. The Candidate must make only ONE INTEGRATED File in "PDF Format" as his/her duly filled Application. All the Annexures must be compiled in an organized manner in the aforementioned integrated singular file as per their serial number.
  8. This file must be uploaded to a **GOOGLE DRIVE FOLDER**. The link to the Google Drive Folder must be added to the Application Form at the relevant area and must also be shared through the Google Form for the collection of Application Forms. The procedure for uploading the File to the Google Drive Folder and for sending the application may be viewed at: <https://canfoundation.in/project-eklavya>.
  9. The scanned files must be converted to OCR compatible. There are numerous free editing software available that make files OCR Compatible such as FOXIT PDF. These software's also allow for the merging of PDFs.
  10. This integrated file must have bookmarks created through the software for all the Annexures. The bookmarks must be as per the nomenclature provided in the index. The total File Size must not exceed 100MBs. The name of the file must be in the following format:

### **ELIGIBILITY CRITERIA**

- a.) The student must be enrolled in an **Undergraduate** Programme (5-year Integrated or 3-year LL.B.) at any **National Law University (NLU)** with a **minimum of 65% aggregate/average marks in the last 3 Semesters**. (A student in the 2nd year of study may send records of the semesters they have completed). 1<sup>st</sup> Year Students (Batch of 2024-2029 or Batch 2024-2027) are not eligible to apply under Eklavya 2024.
- b.) The Candidate must provide an undertaking that their scholarship shall be discontinued in the future, if the Candidate fails to secure a minimum of 65% marks in any subsequent trimester/semester following the grant of Scholarship to them. However, this condition would be suitably relaxed in the face of extreme unforeseen emergencies/contingencies occurring with the candidate as allowed by the Selection Committee.

#### **Explanation:**

- (i) Such marks obtained are in respect of one particular trimester/semester, cumulative of all subjects.
  - (ii) The word 'extreme', in this case, shall mean to construe a condition rendering the Candidate incapable of attending classes. The decision of the Selection Committee, exercising its discretion in this regard, shall be final and binding.
- c.) The **annual cumulative family income** (of Father, Mother, unmarried Brother or unmarried Sister) in the **last 3 Financial Years** on the date of application should have been **less than Rs. 8 Lakhs per year**, including the current Financial Year as per the ***ITR filed with the IT department***.
