The Ministry of Affairs, Food and Public Distribution, Department of Consumer Affairs, Govt. of India, New Delhi has appointed Prof. (Dr.) G.S. Bajpai, Vice-Chancellor, Rajiv Gandhi National University of Law (RGNUL), Punjab, Prof. Anand Pawar, Registrar, RGNUL, Punjab and Justice Paramjeet Singh Dhaliwal, Former Judge, Punjab and Haryana High Court and former President of State Consumer Dispute Redressal Commission, Punjab as members of Committee for conferring Statutory Status to the 'Right to Repair' under the statutory framework of the Consumer Protection Act, 2019. This newly constituted committee shall examine and undertake measures to develop a policy, meet various stakeholders in different parts of India to develop a policy framework, recommend legislative framework and research international best practices. The committee shall submit its recommendations within six weeks.

Consumer Ministry Committee features RGNUL to develop Framework on Right to Repair

Three members of Rajiv Gandhi National University of Law, Punjab feature in the newly constituted Committee by Department of Consumer Affairs for development of framework on 'Right to Repair'. Prof. (Dr.) G.S. Bajpai, Vice-Chancellor, Rajiv Gandhi National University of Law (RGNUL), Punjab, Prof. Anand Pawar, Registrar, RGNUL, Punjab and Justice Paramjeet Singh Dhaliwal, Former Judge, Punjab and Haryana High Court and LL.D candidate at RGNUL have been selected as members of the Committee. Notably, an article titled 'Upholding Right to Repair'in Indian Express penned by Prof. G.S.Bajpai attracted the attention of policy makers. This Committee is to submit its recommendations within six weeks. It will examine and undertake measures to develop a policy, meet various stakeholders in different parts of India to develop a policy framework, recommend legislative framework and research international best practices. The Ministry through effective legislation and framework aims to harmonise trade betweenthe original equipment manufacturers and the third party buyers & sellers.

Advocacy Pilot Project on Wrongful Prosecution Launched 18 July 2022

A Panel Discussion to launch a Pilot Advocacy Project on Wrongful Prosecution was organized on 18th July 2022. Dr. K.P. Singh, Former DGP, Haryana; Dr. G.K. Goswami, ADGP, U.P.; Ms. Malvika Singh, Advocate Punjab & Haryana High Court, Prof. (Dr.) G.S. Bajpai, Vice-Chancellor, RGNUL, Punjab and RGNUL Faculty discussed



crucial issues, objectives, role of stakeholders, point of intervention and working of the Pilot Project of Advocacy on Wrongful Prosecution. Dr. Goswami observed that transparency in evidence collection is integral to fair investigation. "Fair investigation is precursor to free trial," he said. Dr. K.P. Singh deliberated on the importance of intervention of police for proper investigation of cases, "The Criminal Justice Professionals and policy makers should learn lessons from research on Wrongful convictions and apply findings to right the wrongs of erroneous convictions" Prof. Anand Pawar, Registrar, RGNUL opined, "RGNUL's Pilot Project on Advocacy for Wrongful Prosecution is an attempt to address miscarriage of justice. This project aims to facilitate the development of holistic policy for the innocent victims."

She emphasized on critical thinking abilities, the application of knowledge and public service commitment. "Students must align skills create footprint, be open to learning, swim against the currents as everything begins with thought and vision. Reflections on Criminal Justice in **Numbers 27 - 28 August 2022**

Two day Colloquium spread across various technical sessions witnessed presentations by eminent speakers, Ms. Maja Daruwala, Chief Editor, India Justice Report, Ms. Sakshi Sawhney,

IAS, Deputy Commissioner, Patiala, Mr. Sanjay Vashishtha, Member, Indian Police Foundation; Dr. Sunil Chauhan, Former Director National Legal Services Authority (NALSA) and Session Judge, Haryana; Ms. Apoorva, Vidhi Centre for Legal Policy; Shri N Ramachandran IPS (Retd.) Founder & President Indian Police Foundation; Ms. Neha Sinha, Deputy Director & Associate Fellow Artha Global; Ms. Maitreyi Mishra, Head Mental Health & Criminal Justice Project 39A; Ms. Radhika Jha, Lead Researcher, Common Cause; Samita Research Associate, Daksh. Representatives from Vidhi, NALSA, DAKSH participated in the discussion. Ms. Sawhney observed, "Data related to crime enables governance to respond better." As a policymaker, she expressed her concern regarding systemic deficiencies that obstructed deliverance of justice. Eulogising the efforts of Government of Punjab, Ms Sawhney remarked that the government had hired qualified persons in different wings to analyse data, mapped the details of parameters adopted to assess States for their efficiency in providing justice to the citizens. Prof. G.S. Bajpai, Vice-Chancellor, RGNUL scrutinized data utilisation system in the present times and observed, "In order to address inadequacies in the justice system, scientific temper must be developed." "Criminal Justice system institutions are one of the least measured systems in the country," he observed. Prof. G.S. Bajpai said, "In the name of data only crime rate is available. The



survey on various parameters and gathering of data related to profile of victims, evidence, offender and offence can greatly address inadequacies prevailing in the justice system." While dwelling on planning, management, execution and implementation of data, Prof Bajpai spoke about the need to improve data literacy. Prof Anand Pawar, Registrar, RGNUL extended a vote of thanks. Participants from India and abroad attended the session.


International Faculty Development Program on Law and Social Sciences 12-17 September 2022

He exhorted lawyers to reserve time for providing legal aid to the poor and underprivileged. He emphasized that cognitive training of functionaries and appropriate framework for empirical investigation of victimization of vulnerables could be plausible alternatives to avoid delay in justice. Trial delays thwart the safety of victims deprived of justice. He narrated instances from the court of King Vikramaditya and Jahangir. He congratulated CCV, RGNUL for organising conference on pertinent issue related to the rights of victims of justice. "I am sure that deliberations of the conference in form of paper would aid the processes of justice," Shri Purohit said.



The moot problem centered on cannabis sector investment in a host state which was devastated due to armed conflict and civil war within the country. This included an investor-State arbitration under the ICSID Convention and raised issues of Res Judicata, Exhaustion of Local Remedies (ELR), Full Protection and Security (FPS), Extended War Clause and Moral Damages.

Another team comprising of Xenia Dhar, Samiksha Agarwal and Muskan Garg (3rd year) was Quarter-Finalists in Jurisprudence 2022 National Space law moot organized by Quantum University, Roorkee, from 25th to 27th August 2022. Muskan Garg won the Best Researcher Award.

This was followed by conflicts, deadlock clauses and negotiations between Langad Hotel Group and Mordon Gamsey (world renowned chef).

Prof. G.S. Bajpai, Vice-Chancellor, RGNUL while congratulating the winners observed, "Negotiation is an amicable method to settle international disputes. Students of law must develop skills of negotiation to evolve an agreeable formula that advances the notion of justice". Participation in such competitions fortify communication skills of students."
