**Subject: Release of Grant-in-Aid to Rajiv Gandhi National University of Law, Punjab, Patiala during the year 2022-23 under Central Sector Scholarship Scheme of Top Class Education for SC students [renewal for the year 2020-21(3<sup>rd</sup> and 5<sup>th</sup> year)].**

Sir,

I am directed to convey the approval of the President of India for Sanction of Rs.3,84,000/- (Rupees three lakh eighty four Thousand only) and release of Rs.3,02,000/- (Rupees three lakh two thousand only), as institute part for the year 2020-21(3<sup>rd</sup> and 5<sup>th</sup> year), towards Grant-in-Aid to **Rajiv Gandhi National University of Law, Punjab, Patiala, here-in-after called RGNUL** during the year 2022-23(Recurring/Non- Recurring) under Central Sector Scholarship Scheme of Top Class Education for SC students as per details given in Annexure enclosed herewith. The balance amount of Rs.82,000/- (Rupees eighty two thousand only) will be released to the students through Direct Benefit Transfer (DBT).

2. The Grant-in-Aid will be regulated in accordance with the provisions contained in the guidelines issued by the Ministry of Social Justice and Empowerment Shastri Bhawan, New Delhi. The Grant-in-Aid is also subject to the provisions of Chapter 9 of the General Financial Rules, 2017, as amended from time to time, read with the Government of India's decisions incorporated there-under, and any other guidelines which may be issued in this regard and in particular to the following conditions:-

- I. All relevant information and documents/ certificates as required under GFR 230 (1) has been received.
- II. The pattern of assistance of rules governing such Grant-in-Aid has received the approval of the Ministry of Finance, as required under Govt. of India Decision No. (1) below Rule 20 of DFPR, 1978.
- III. The RGNUL has agreed to make reservations for Scheduled Castes and Schedules Tribes or OBC in the posts or services under its control on the lines indicated by Govt. of India.
- IV. The accounts of RGNUL shall be audited by C&AG or shall be open for inspection by the sanctioning authority and audit, both by the Comptroller & Auditor General of India under the provision of C&AG (DPC) Act, 1971 and internal audit party by the Principal Accounts Office of the Ministry or Department whenever it is called upon to do so.

6. The Grants-in-Aid is sanctioned under the additional powers delegated to this Ministry vide Ministry of Finance Office Memorandum No. F.10 (a) E (coord) 62 dated 1<sup>st</sup> June, 1962.

7. The Direct Cash Transfers (DCT) mechanism has been introduced in 5 number of districts in the State of Punjab. It may be ensured that disbursement of scholarships to the beneficiaries of the Institution in the identified districts is done by way of direct cash transfers to the beneficiaries in their Aadhar enabled bank accounts under intimation to the Department of Social Justice & Empowerment.

8. Further, immediate necessary action may be taken by the Institutions for integration of database of the beneficiaries in their Institution with Unique Identification Authority of India (UIDAI) AADHAR numbers for the purpose of (i) embedding the AADHAR numbers in the database of the beneficiaries for identification and (ii) using the UIDAI AADHAR enabled bank accounts for crediting the scholarships, in those districts where the DCT is yet to be introduced.


