EDITORIAL

Since its establishment RGNUL is moving ahead with each passing year. The commitment to the idea of excelling in academics and research is the propelling force behind all that is achieved. The academic session 2010-11 saw a plethora of activities and achievements to RGNUL's credit. The year began with prize distribution function for ENSAYO 2010 National Essay Writing Competition; followed by Panel Discussion on the topic Gandhi Revisited' exploring the relevance of Gandhi's ideology in contemporary India; the first National Parliamentary Debate Competition Agahi'10 gave the student community the adrenaline rush and also tested their ability, to organize and plan a national event, a two day Multidisciplinary Congress on Political Science and Global Governance was organized to explore the contrasts and affinities of the discipline vis-à-vis other disciplines; followed by the Annual Function in April, a platform awarding all the merit holders and framing the aesthetic aspirations of the students through the cultural show.

Yet another significant milestone was covered with the publication of RGNUL Law Review (RLR), research journal. Its inaugural issue was released by Hon'ble Mr. Justice Ranjan Gogoi, Chief Justice Punjab

and Haryana High Court and Chancellor RGNUL. It is a step towards promoting high quality research and to establish itself as a centre a learning and knowledge. The RGNUL is moving in the direction of its aim to grow and nurture community of academicians who would contribute substantially to society.

Bar Council of India Regulations, 2008 have clearly mentioned that all integrated Law Courses shall have to teach as Minor / Major subjects of Social Sciences and a foreign language as well to strengthen the B.A. Component of the course. RGNUL shall be the first National Law University to undertake the change from the next academic session. Further on, two new specialization streams shall be offered to the students of fourth and fifth year: International Law and Constitutional Law. It will open newer avenues for students both in further studies and employment.

The first batch (2006), of the students will be passing out at the end of this academic session. In these five years keeping in view the paradigm shift in the field of legal education the RGNUL strove in earnest to provide these students with more practical and pragmatic learning environment. The competence, legal acumen and diligence of these students has been acknowledged and awarded at various national and international competitions. The University is confident that the students would prove to be an asset to any organization.



The importance of Legal Aid and Awareness Campaigns as a mechanism for social progress is something that has been repeatedly stressed upon by the Government of India. In the backdrop of poverty and inequality, legal aid is an effective way towards attainment of the ideals of 'Social, Economic and Political' Justice that are enshrined in our Constitution under the Directive Principles of State Policy. The RGNUL Legal Aid Clinic would strive to render Legal Services at the grass root level and also to spread Legal Awareness. It is supported by a team of lawyers, legal advisors, RGNUL faculty, LL.M. Students and student volunteers from B.A., LL.B. Course.

To mark the Earth Day RGNUL organized an Inter-School Quiz Competition at DAV School, Patiala on 27 April 2011 to spread awareness regarding environment and our responsibilities amongst the young students. Twenty four teams participated in this

competition. Professor (Dr.) Paramjit Singh Jaswal, Vice-Chancellor, RGNUL, addressed the teams and appreciated the spirit of the students of RGNUL as well as of the participating schools towards the protection of environment. He said that participation is more important for this cause and not winning. The first three teams were give cash prizes of Rs. 2000, Rs. 2500 and Rs. 1000 respectively.

RGNUL has formed six member Internship and Placement Committee (IPC). On 10th May, 2011, the Hon'ble Vice Chancellor, Professor (Dr.) Paramjit S. corporate offices, senior advocates, clerkship under the Hon'ble Supreme Court and High Court Judges and other related Public Sector undertakings. During the internship the students can test the practical application of the theories of academic learning in the professional setting, and also the students conduct Legal Research, Draft Pleadings, Briefs, Opinions or other Legal Documents as required by the organisation.

The University has become part of National Mission in Education through Information and Technology (NEICT) with the implementation of this scheme RGNUL has become part of National Knowledge Network (NKN) through BSNL which provides 1 Gbps bandwidth connection to the University. The internet connectivity is secured through CYBERROM.

The RGNUL is proud partner of the Legal Information Institute of India (LII of India). It is an institute established in India to provide free online access to Legal Resources of Indian Legislation of the Central, State and Union Territories with case laws and academic legal resources. LII of India at present has 107 databases, including over 300,000 decisions from 37 Courts and Tribunals, Indian national legislation from 1836, over 800 bilateral treaties, law reform reports and about 500 law journal articles. The LawCite citatory tracks case and journal article citation. Further case law, and State and Territory legislation, is regularly updated. Legal Information Institute of India has been accepted as the 34th member of the Free Access to Law Movement (FALM).
