As many as 12 students have already completed doctoral dissertations (Ph. D.) under his guidance. In addition to a Master's specialization in Criminology & Criminal Justice, he holds a doctorate in victimology and a post-doctorate in criminal justice from Leicester University, UK as Commonwealth Fellow at the Department of Criminology, Leicester University, U.K.
