

As per the prevalent practice, RGNUL IQAC initiated the process of obtaining feedback of the faculty from the students. Students were given sufficient time to fill the feedback form for all the faculty members. Total of 1306 online forms were received. The feedback parameters are comprehensive including the punctuality in taking classes, teaching the course curriculum, delivery of structured lectures, helping attitude, classroom discussions, reference to latest developments in the field etc.  These forms have been analysed ensuring strict confidentiality. The analysis of responses for each individual faculty member has been put on record. It is a matter of satisfaction that almost all faculty members have been given very good feedback by the students. Those faculty members where some improvements were required were counselled by the university authorities. The Action Taken Report is annexed herewith as (Annexure-3).
