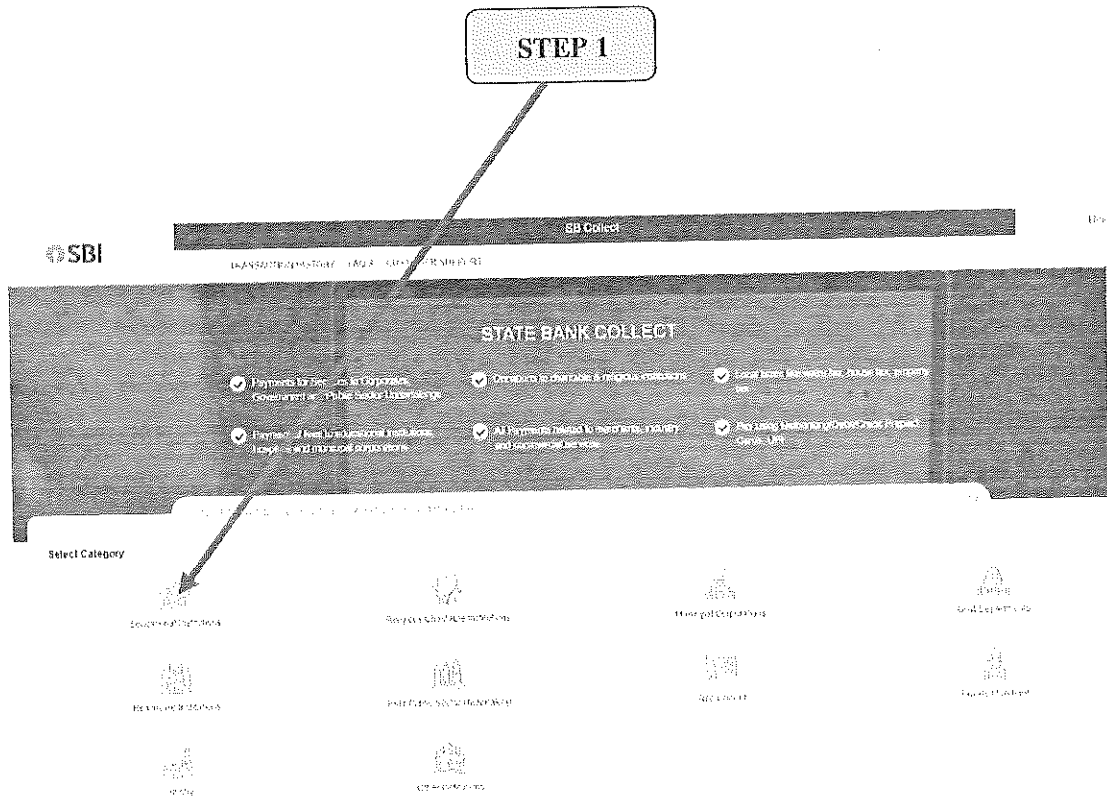

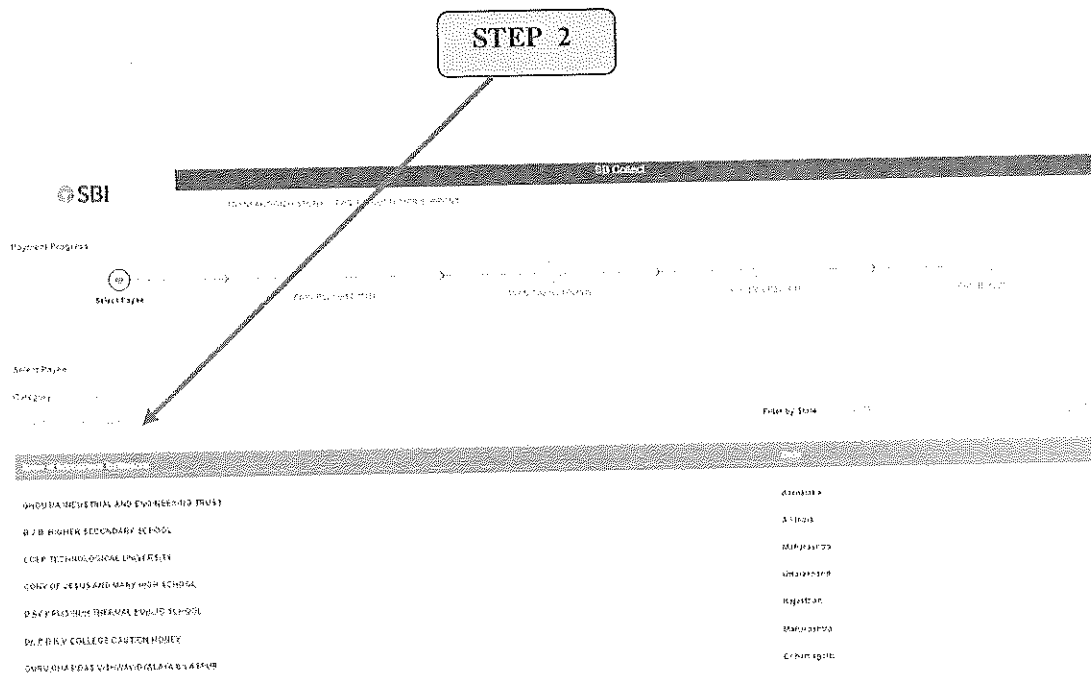

After clicking the link <https://www.onlinesbi.sbi/sbicollect/collecthome.htm> you get the SBI Collect Portal as shown in Step 1.

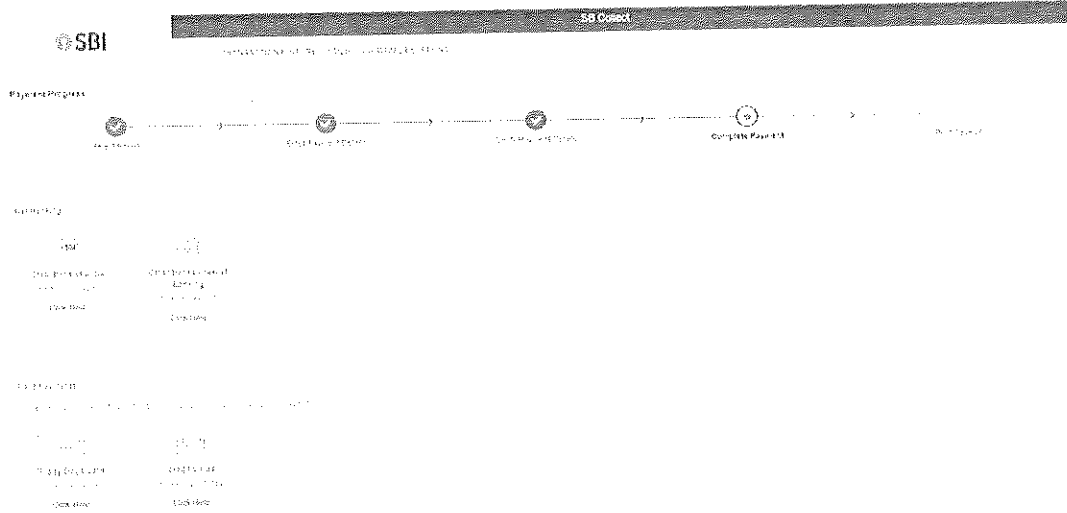


- Select the Educational Institutions icon
