Patenting should be done with an intelligent strategy that aligns business interests to implement the technology with a wide range of options in the search for how, where and when to patent. We also learnt that with a focus on international considerations and regulations in specific countries, it is possible for a company to achieve significant savings and improve the rights gained using patents.

**Speaker 2. Dr. Sunil Kumar, Examiner of TM & GI, GOI.**
