# Editorial

# Lecture on Section 6, Hindu Succession Act, 1956, delivered by Prof. Vijender Kumar Vice-Chancellor, MNLU, Nagpur on 16th October 2020.

Prof. Vijender Kumar, Vice Chancellor, MNLU Nagpur delivered a lecture on the provisions of the Hindu Succession (Amendment) Act, 2005. He emphasised upon the fact that the amendment was required with an objective of removing gender discrimination in matters of inheritance. In his lecture, he made reference to various landmark judgements on the amendment and cleared the controversies on the questions of law of status and position of daughter, execution date of the amendment and its retrospective nature.

# Lecture on 101st Constitutional Amendment of the Indian Constitution, on 23rd October 2020.

The Centre for Constitutional Law and Governance organised a lecture on 101st Constitutional Amendment of the Indian Constitution, on 23rd October, 2020. Dr. Manoj Sharma, Assistant Professor of Law, was the key speaker. In his lecture, he delved upon the scenario in India prior to the introduction of GST Act, which was introduced vide the 101st Amendment to the Indian Constitution and became effective from July 1, 2017. The lecture enlightened the students about the problems faced on account of multiplicity of taxes prior to the implementation of the GST regime and also highlighted the apprehensions being faced by the trader class with regards to the registration process related to GST.

Further, he shared real life problems faced by him and his team when he was working in law firms.

Vikramjit Banerjee, ASG, Supreme Court of India, delivered a lecture on Decoding Essential Practices Test. The lecture dealt with the essential practices attached to a particular religion. 
### **One Day Training Session on Academic Writing** (18th March 2021)


