FEE REFUND POLICY FOR ACADEMIC YEAR 2026-27(First Semester Only for B.A.LL.B. (Hons.) and LL.M.)

1. **Eligibility for Refunds:** Refunds will be made to students cancelling/withdrawing admission from any academic programme within a time specified by the university subject to the guidelines issued by **BAR COUNCIL OF INDIA (BCI) Circular no. D6161/2023 norms issued dated 20.10.2023**. The closing date of the admission is 15th July 2026 for the Academic Year 2026-27.

1. **Refund Calculation:** The refund amount will be calculated based on BCI refund policy as applicable on the date of cancellation/withdrawal of admission subject to the following deductions;

• **Tuition Fee & Other Fees (Excluding Hostel Fee & Mess Fee):-**

Cate gory	Percentage of Refund of Fee	Point of time when notice of withdrawal of admission is received	Date of the Refund
1.	100%	If the student files an application for withdrawal of admission 15 days before the last notified date of admission	For withdrawal requests received upto 30 th June 2026, 100% University fee refund will be given
2.	90%	If the student files an application for withdrawal of admission less than 15 days before the last notified date of admission but within 30 days after it	For withdrawal requests received between 1 st July 2026 to 14 th August 2026, 90% refund will be given.
3.	80%	If the student files an application for withdrawal of admission between 31 and 60 days after the last notified date of admission.	For withdrawal requests received between 15 th August 2026 to 14 th September 2026, 80% refund will be given.
4.	00%	If the student cancel the admission 61 days or more after the last notified date of admission.	No refund will be given for withdrawal requests received after 14 th September 2026, including cases where admission is granted against a vacant seat

• **Deduction of Rs. 5000/- as processing fee, RTGS/NEFT charges including administrative charges shall be charged by the University on account of cancellation of admission of students in all cases.**

• **Hostel Fee & Mess Fee**

For the Hostel and Mess Service availed by the student from the Commencement of classes the refund will be made after deducting the charges in the following manner;

- Students availing Hostel & Mess services for 0-15 days will be charged for a block of 15 days.
- Students availing Hostel & Mess services beyond 15 days will be charged for the entire month.

iii) In case of withdrawal or cancellation of admission, the request for the refund must be sent to abhinandan@rgnul.ac.in , Office@rgnul.ac.in & accounts@rgnul.ac.in . Please note that no interest shall be paid on refund of fees under any circumstances.
