Applicant with experience of working in a Government / Educational Institution will be preferred.

1. Name of the post applied for must be superscripted at the top of the envelope as: "Application for the post of **Helper to AC Mechanic**".
2. Candidates applying for a post must ensure that they fulfill all the eligibility conditions on the last date fixed for receipt of applications i.e **23-06-2023**. If on verification at any stage, before or after the selection, it is found that the candidate did not fulfill any of the eligibility condition(s) as on the last date or the information furnished is false or incorrect, his candidature will be canceled/his services will be terminated.
3. The possession of a prescribed essential qualification does not entitle a candidate to be called for skill proficiency test. The decision of the University in all the matters relating to acceptance or rejection of an application, eligibility/suitability of the candidates, or the criteria for selection, etc. will be final and binding on the candidates. No inquiry or correspondence will be entertained in this regard.
4. Incomplete applications or the applications received without the prescribed fee or received after the last date of receipt of applications will be rejected and no correspondence will be entertained in this regard.
5. In case, the last date falls on a holiday, the next working day shall be treated as the last date.
6. Those who are already in employment required to submit their Application Form through proper channel.
7. Concealment of facts or supply of wrong information will result in cancellation of candidature in addition to legal action.
8. Candidates shall be called for the skill proficiency test after due scrutiny and short listing of the applications. Being eligible shall not confer any right to be called for the skill proficiency test.
9. The University reserves the right to withhold the post at any stage before appointment.
10. The appointment shall be subject to the verification of antecedents.
11. The University reserves the right to determine the term and conditions for the above said post.
12. The candidates should not be less than 18 years and not more than 40 years in age on the date of the skill proficiency test.
