2. Candidates applying for a post must ensure that they fulfill all the eligibility conditions on the last date fixed for receipt of applications. If on verification at any stage, before or after the selection, it is found that the candidate did not fulfill any of the eligibility condition(s) as on the last date or the information furnished is false or incorrect, his/her candidature will be cancelled/his/her services will be terminated.
3. The possession of a prescribed essential qualification does not entitle a candidate to be called for the Skill Proficiency Test. The decision of the University in all matters relating to the acceptance or rejection of an application, eligibility/suitability of the candidates, or the criteria for selection, etc. will be final and binding on the candidates. No inquiry or correspondence will be entertained in this regard.
4. The eligibility of every candidate will be determined on the basis of qualifications acquired and communicated to the office by him/her up to the last date fixed for receipt of applications. No certificate/document will be considered after the last date.
5. Incomplete applications or applications received without the prescribed fee or received after the last date of receipt of applications will be rejected and no correspondence will be entertained in this regard.
6. In case, the last date falls on a holiday, the next working day shall be treated as the last date.
7. Those who are already in employment are required to submit their Application Form through the proper channel.
8. Concealment of facts or supply of wrong information will result in cancellation of candidature in addition to legal action.
9. The incumbent possessing advanced skills, experience, and abilities demonstrated by the type of institutions served, goals achieved, research carried out and impact made would be deciding factors in keeping the higher standards of national-level higher education institutions conducting the professional courses in a competitive ecosystem.
10. Candidates shall be called for the Skill Proficiency Test after due scrutiny and shortlisting of the applications. Being eligible shall not confer any right to be called for the Test.
