### Constitution of Internal Complaints Committee under Section 4 of the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013.

1. The Government of India has notified the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Rule 2013 in the Gazette of India, Extra Ordinary on 9<sup>th</sup> December 2013, under the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 (Act 14 of 2013) (Hereinafter referred as Act). As such the provisions of the Act are in force w.e.f. 9 December 2013 in terms of Section 1 (3) of the Act.
