The complete Bidding document / DNIT can be obtained from office against Demand draft for 1000/-+18% GST=1180/- (Non-refundable) between 9.00 AM to 4.00 PM from 28.06.2023 to 07.07.2023 up to 10:00AM.

Earnest money of the unsuccessful bidders shall be refunded after the allotment of work. Earnest money of the lowest bidder shall be refunded after successful completion of the work . The agency will also furnish copy of valid enlistment, copy of PAN, EPF, ESI, GST registration. No bid/ Quotation will be entertained without EPF and ESI registration number.
