#### 2. TERMS AND CONDITIONS

#### A. Tender Submission and Evaluation

- Rates must be inclusive of all taxes, installation, configuration & warranty.
- Delivery & installation must be completed within 30 days of supply order.
- Payment will be made after successful installation & verification by the IT Department.

#### **B. Contractual & Financial Conditions**

- Earnest Money Deposit (EMD): Bidders shall submit an EMD of Rs. 10,000/- in the form of a Demand Draft issued by a reputed, preferably nationalized bank, in favour of "Registrar, RGNUL Punjab" Payable at Patiala. The EMD of unsuccessful bidders will be refunded after finalization of the tender. The EMD of the successful bidder will be refunded after satisfactory completion of supply, installation, and acceptance of the work.
- University reserves the right to accept or reject any tender without assigning reasons.
- Subletting/assignment prohibited.
- Non-compliance or delay allows University to execute order at bidder's risk & cost.
- Statutory taxes will be deducted as per norms.
- Bidder responsible for any damage to University property during installation.

• Warranty: **Minimum 5 Years Comprehensive Onsite OEM Warranty** (including hardware, battery minimum 2 years, charger, and all components).

### **C. Site Requirements**

- The workstation/laptop must be completely installed and configured at the IT Office.
- Vendor must demonstrate successful live streaming readiness at the time of installation.

### **D. Security Clause**

- 1. The supplier shall provide only **new, original, and sealed OEM equipment**.
- 2. No unauthorized or third-party software shall be installed on the laptop.
- 3. The supplier shall not access or copy any University data during installation.
- 4. Any information shared by the University for installation purposes shall be **kept** confidential.
- 5. The supplier will be responsible for any damage or security issues caused by their staff during delivery or installation.
- 6. The supplier's representative must follow basic entry/exit rules of the University while visiting the campus.
- Vendor liable for misconduct or damage caused by their staff.
