- iii. High pressure washing with mild h2o2 based solution.
- iv. Scrubbing walls, floors and top with nylon and wire brushes.
- Vacuum cleaning and removing solid contamination (Mud waste, algae slurry or organic waste if present.
- vi. Complete disinfection including spraying disinfectant Huwa San TR50 (H2O2 AG+IONS) and UV Lamp air germicidal radiator.
- The schedule for cleaning will be discussed by your representative with RGNUL staff in advance.
