12. Bidder should have also furnish copy of valid enlistment, copy of **PAN, EPF, ESI, GST Registration.**
No bid will be entertained without EPF and ESI registration number.
 13. Average Annual financial turnover during the last three years ending **31.03.2026 should be at least 50% of the bid cost.**
 14. If date of opening of Technical Bid/Financial bid, is declared holiday by RGNUL, the tender will be opened on the next working day.
 15. Original documents can also be seen by the RGNUL, any document found fake at any time can be debarred & black listed & the earnest money or any other amount due to the respective agency can be forfeited.
 16. The bidder will abide himself by all the labour laws.
