#### **Additional Terms & Conditions:-**

The important terms and conditions are listed below for convenience:

- 1) The Contract Agreement would be effective from 1st Feb 2026 to 31st Dec 2026 (11 months) and can be renewed with minimum 5% increase in rent for the second year. This extension of the contract for second year will be subject to satisfactory performance of the Contractor.
- 2) The Agency/bidders are advice to visit the University in order to examine the location/any other related information of above mention **shops** before quoting the rate.
- 3) Kindly stamp and sign all pages of the tender. Deviations if any shall be highlighted on a separate sheet on the tenderer's letterhead.
- 4) For any clarification regarding this job, the bidders can contact Phone No 0175 2391600-601, 602,603 Extension 419 & e-mail: cmw@rgnul.ac.in
- 5) The annually minimum base rent of Shop will be as per above list + GST as applicable
- 6) The rent of the Shop will be charged in advance in two instalments i.e. 1st for six month rent and 2nd for five month at the time of the start of contract.

- 7) The Contractor will have to pay electricity charges per unit rate on actual consumption of electricity monthly. (As per Meter Reading)
- 8) The Contractor will sell only those items in the shops which are allowed by the RGNUL and will get the rates of all the items approved from the competent authority of the RGNUL and they must be displayed prominently. The name of the firm and of the counter must be also displayed prominently.
- 9) The cost of erection and all installations inside the Shop will be solely borne by the Contractor.
- 10) Proper measures of cleaning and putting the litters of the disposables/papers etc. in the dustbins has to be taken care by the Contractor.
- 11) The Contractor will be liable to pay all taxes levied by the government.
- 12) The RGNUL, Punjab shall be entitled to claim damages for mishandling the furniture and fixtures and fittings installed in the area provided. Penalty will be imposed on the Contractor in addition to the cost of repairs and replacements which are to be borne by the Contractor.
- 13) Engaging of required staff, providing uniforms etc. shall be done by the Contractor with the approval of the RGNUL, Punjab. The Contractor must submit the ID proof and police verification documents of all its employees working in the Shop. If any staff of Contractor is found misbehaving with any Faculty, Staff or Student of RGNUL, Punjab, strict action will be taken against the Contractor.
- 14) The RGNUL, Punjab would reserve the right to check on cleanliness and upkeep of premises, quality of provisions, and any deficiency found penalty procedure will be applied.
- 15) The Contractor should submit all necessary statuary documents. (Aadhar Card, PAN Card & GST Number if required).
- 16) The Contractor should adhere to the provisions of the GST, Provident Fund Act, the Minimum Wages Act and other such acts which are applicable.
- 17) The Contractor will adhere to all laws of the land at his own responsibility and costs. The RGNUL, Punjab will not be responsible for life and safety at the workplace; the staff of the Contractor should be duly insured.
- 18) Consumption of alcohol or alcoholic beverages and smoking is banned in the University. Any violation will attract legal action and the contract will be terminated.
- 19) The Contractor will not sublet the contract. If found so, it will invite termination of contract and forfeiture of security.
- 20) The RGNUL, Punjab reserves the right to make any amendments in the Terms & Conditions as & when required and deemed fit and mutually accepted to both the parties.
- 21) In the event of the any dispute with regard to any of the term(s) and/or conditions of this agreement, the same shall be referred to the Vice-Chancellor/Competent Authority and dispute be referred on mutual agreement to sole arbitrator/mediator and its decision thereon shall be final and binding on both the parties, further it will be subjected to the jurisdiction limits of Patiala District.

#### Penalties for violation of rules, terms and conditions

#### The Contractor will be fined in case of violation of the following rules:

- The Penalties or Fine can be imposed in violation of rules, terms and conditions and with regard to the discrepancy found in the cleanliness of Shop, personal hygiene of workers, changing of the employed staff without information to the RGNUL, Punjab, charging rates of the items not approved by the RGNUL, Punjab, etc.
- 2) The Contractor will be given a warning in writing initially, thereafter a fine of Rs. 5,000/-, if again found defaulter fine can be increased up to Rs. 10,000/- and if again found defaulter the fine will be Rs. 20,000/- and after all these impositions again any complaint comes it will lead to the termination of the contract.
- 3) Absence of the Contractor or his representative from meeting called by the RGNUL, Punjab will attract a fine of Rs. 5,000/- on the Contractor.
