1. ELIGIBILITY CRITERIA

Only those bidders who fulfill the following criteria shall be considered eligible to participate in this tender:-

2. TERMS AND CONDITIONS

A. Tender Submission and Evaluation

- 1. The tender should be submitted in a sealed envelope clearly superscribed as "Tender for Purchase of Projector for Seminar Hall."
- 2. Bids should be dropped in the Tender Box kept at the University Reception.
- 3. The last date for submission of Tender is 19 November 2025 up to 3:00 PM.
- 4. The Tender will be opened on the next working day at 3:30 PM in the presence of the bidders who wish to attend.
- 5. Rates must be quoted inclusive of all taxes, installation, and warranty charges (SITC).

- 6. The supplier must be an authorized dealer or partner of the quoted brand, and a valid authorization certificate (MAF) must be enclosed.
- 7. The University reserves the right to accept or reject any or all Tender without assigning any reason.
- 8. The item must be delivered and installed within 30 days from the date of issue of the supply order.
- 9. Payment shall be made after successful installation, testing, and verification by the IT Department and submission of installation report by the successful bidder.

B. Contractual and Financial Conditions

- Earnest Money Deposit (EMD): Bidders shall submit an EMD of Rs. 10,000/- in the
 form of a Demand Draft or Cheque issued by a reputed, preferably nationalized
 bank, in favour of "Registrar, RGNUL Patiala." The EMD of unsuccessful bidders will
 be refunded after finalization of the tender. The EMD of the successful bidder will be
 refunded after satisfactory completion of supply, installation, and acceptance of the
 work.
- 10. Non-Transferability of Work: Subletting, assigning, or transferring the awarded work, in whole or in part, is strictly prohibited. Violation of this clause shall result in termination of the contract and forfeiture of EMD.
- 11. Right of Rejection: The Tender Allotment Committee reserves the right to accept or reject any or all bids without assigning any reason. The Committee's decision shall be final and binding.
- 12. Timely Execution: The entire work, including supply, installation, and commissioning, must be completed within one (01) month from the date of issue of the acceptance or supply order.
- 13. Compliance and Risk Clause: In the event of non-compliance with University instructions, delay in completion, or failure to rectify defects within the stipulated period, the University reserves the right to execute the work through any other agency at the risk and cost of the defaulting firm.
- 14. Tax Deductions: Income Tax and other applicable statutory deductions shall be made from the firm's bills as per prevailing Government norms.
- 15. Liability for Damages: The firm shall be fully responsible for any damage caused to University property during the execution of work and shall make good all such damages at its own cost.
- 16. Warranty: The supplied projector shall carry a minimum three (03) years onsite OEM warranty covering the projector, optical components, and laser light source (or 15,000 hours of operation, whichever is earlier). The supplier shall provide free replacement or repair of defective components during the warranty period and ensure prompt service support through an authorized service centre within 30 km of RGNUL Patiala.

C. Site Inspection

- 1. Tenderers may, if they wish, inspect the site to understand the conditions, scope of work, and nature of installation before submitting their tender.
- 2. The site address is: Rajiv Gandhi National University of Law, Sidhuwal, Bhadson Road, Patiala (Seminar Hall).
- 3. The site can be inspected on any working day between 10:00 hrs and 15:00 hrs with prior intimation to the University authorities.
- 4. It will be the responsibility of vendor to install the projector in seminar hall and also make sure that the display of the screen should be proportionate as per present draper make screen installed in the Seminar hall. The detail of the screen and distance from present mount kit installed in the seminar hall is as under:-
- 5. "ELECTROL® 16:10 WIDE FORMAT 7.3" x 11.8" (165" Diagonal) with 1 Feet Black Drop Draper Draper Luma2 (Motorized)"Draper Luma2, 165-inch diagonal, 16:10 aspect ratio, with a 1-foot black drop
- 6. The distance of projector mount from screen is approx. 22 feet.

D. Security Clause

The contractor shall ensure strict compliance with the Code of Conduct as outlined below:

- 1. Maintain high standards of security, cleanliness, and hygiene within the University premises.
- 2. Follow best behavioral practices and maintain decorum at all times.
- 3. Be aware that all areas are under 24×7 CCTV surveillance.
- 4. Smoking, chewing gutkha, pan, or spitting inside the University premises is strictly prohibited.
- 5. Dispose of all waste only in designated bins and areas.
- 6. Take necessary precautions against fire and know the fire exit routes.
- 7. Declare all assets or materials taken out of the University and ensure proper Gate Pass authorization.
- 8. Do not disclose any information related to the University or its infrastructure to unauthorized persons.
- 9. The contractor shall be responsible for the conduct and discipline of all personnel deployed by them.
- 10. The contractor shall be liable for any damage or loss caused to University property due to negligence or misconduct of their personnel.
- 11. The contractor shall take appropriate disciplinary action against their staff for any act of misconduct, including discharge or dismissal, in accordance with applicable labour laws.

E. Jurisdiction

The contract shall be deemed to have been executed at Patiala, and all disputes arising from or related to this tender shall fall under the exclusive jurisdiction of the Courts at Patiala (Punjab).
